Saadé warns Marseilles to resolve port unrest or CMA CGM will walk

Ten ships already forced elsewhere, says company boss, writes Andrew Spurrier — Thursday 5 April 2007

MA CGM chairman Jacques Saadé has warned that the group will take its business to other ports in the Mediterranean if Marseilles is unable to resolve its industrial relations problems.

Mr Saadé told French newspaper Le Monde that the group, which has its headquarter in Marseilles, had already been obliged to send 10 vessels to Genoa, Barcelona and Valencia during the week in which the recent strike at the port's oil terminals was extended to other cargo terminals.

He said it is essential that the French authorities, the port, unions and shippers work together to re-establish peaceful industrial relations before the port's new container extension, Fos 2XL, comes into service at the end of 2009.

He made no threat to divert the group's vessels away from Marseilles in the short term but, asked what would be the group's reaction if peace efforts failed, he said: "The CMA CGM group will be obliged to unload containers destined for Marseilles-Fos in other Mediterranean ports like Genoa or Barcelona and the Marseilles and Fos terminals will lose definitively all the containers in transit which we hope to develop."

Mr Saadé was also critical of the port's operational performance, indicating that container handling rates at Marseilles stood at 50 movements per hour, compared with 120 in Le Havre and 320 in Chinese ports.

He added that the port is already off the main international trade routes and is an essential point of passage only for containers destined for southern France.

Mr Saadé's comments coincided with expressions of outrage from employers' bodies in the Marseilles region and the French shippers' organisation, AUTF, at alleged French government pressure on Gaz de France to accept the strikers' demands for jobs at its new Fos LNG terminal.

AUTF delegation general Philippe Bonnevie said the government had forced the port authority and GdF to give in to the strikers.

He claimed that the five posts which had been offered to port personnel at the new

LNG terminal were "fictitious like numerous others in French ports."

Marc Reverchon, head of the Marseilles-Fos port employers' body, described last weekend's strike settlement agreement as an ignominious retreat and accused the government of taking a "short-term decision prejudicial to the port."

The government is believed to have exerted pressure on GdF to settle the dispute last week because of fears that it could lead to a petrol shortage in the final stages of the campaign for the French presidential elections, due to take place on April 22 and May 6.

Somali pirates hijack a second merchant ship

SOMALI pirates have taken a merchant vessel captive, the second such seizure in the past five weeks.

The ship was boarded by 10 armed hijackers as it entered capital city Mogadishu on Monday. The International Maritime Bureau was yesterday seeking confirmation of the identity of the ship, thought to be named Nimatullah.

No ransom demand has yet been lodged for the 14 seafarers on board.

The ship's charterer, Somali businessmen Hussein Ali Jillow, said: "The crew told us by telephone that they had been hijacked by Somali pirates. The crew did not say anything about their conditions."

This hijacking follows the capture in February of Rozen — on charter to the United Nations — with a crew of six Kenyans and six Sri Lankans on board.

The men are still being held off the coast of the semi-autonomous Puntland region, although there are reports from Kenya of negotiations over their future.

Meanwhile, reports from the crisis-torn African nation suggest that up to 47,000 people have fled Mogadishu over the last two weeks following fighting between the interim government backed by Ethiopian forces and Islamist rebels. Human rights groups believe at least 381 people — probably many more — have died as a result.

A.MERT (St. Vincent & Grenadines)

London, Mar 24 - According to Lloyd's MIU AIS, general cargo A.Mert was located stationary 15.5 nautical miles off Laurium, in lat 37 29 30.56N, long 23 54 52.63E, at 1453, UTC, today. London, Mar 29 — General cargo A.Mert arrived Piraeus Mar 27 from Turkey.

ACCORD (Philippines)

Manila, Mar 28 - General cargo Accord is still aground near the Curangon shoal in Malinao town, Albay. Officials from Matsya Shipping Corp, the vessel's owner, said that they were still awaiting instructions from the cargo insurer, state insurance agency Government Service and Insurance System (GSIS), on how to dispose of the rice remaining in the the vessel's cargo holds. The vessel was carrying 58,000 bags of government-owned rice when it ran aground on Jan 17. Since then, close to 90% of the rice has been contaminated by seawater and oil. The rice has to be offloaded to lighten the vessel before refloating operations can be carried out. The rice, however, cannot be offloaded without the consent of the GSIS. — Lloyd's List Correspondent.

AFRODITE S.

(St. Vincent & Grenadines)
Antalya, Mar 22 — We are the owners of tug Antak which salved and towed general cargo Afrodite S. to Marmaris Bay, where it arrived 1235, Mar 17. The vessel is still at anchorage in Marmaris Bay (not as reported in issue of Mar 23) where salvors, Antmarin Inc, will conduct minor cargo shifting operations to correct its five degree listing to port side. There is no damage to its cargo of 4.032 tons of bulk cement. Furthermore some minor engine repairs will also take place in Marmaris. - Lloyd's Subagents.

Antalya, Mar 29 — After being abandoned by its crew general cargo Afrodite S. was salved by tug Antak, of salvor Antmarin Inc. and is still at anchorage in Marmaris Bay with a five degree list to port side due to cargo shifting. No damage reported on cargo which is to be trimmed for vessel stability purposes. There are minor engine deficiencies. The vessel being detained by salvors. - Lloyd's Subagents.

AJAX (Poland)

London, Mar 27 — A press report, dated today, states: Rudder trouble on general cargo Ajax (14169 gt, built 1982), Porto Marghera to Ilichevsk, while entering Dardanelles, in front of Kumkale at around 1000, local time,

London, Mar 28 - According to Lloyd's MIU AIS, general cargo Ajax was located four nautical miles off Beykoz, in lat 41 04 28.02N, long 29 03 $\,$ 10.98E, at 0835, UTC, today, course 20 deg, speed 11.2 knots.

London, Mar 29 — Survey of general cargo Ajax controls (rudder) was completed at 1525, Mar 27 and the vessel was permitted to proceed for at 1625, same day.

ALERT (U.S.A.)
London, Mar 29 — A press report, dated Mar 28, states: A crew of about 20 antique ship aficionados and Coast Guards worked all night and then awaited a dry dock berth, today, as they tried to save the 80-year-old research Alert (198 gt, built 1927), which was heavily damaged after being set adrift. In an apparent act of vandalism, the vessel was released from its mooring early Monday (Mar 26), at the Thunderbird Hotel on Hayden Island (lat 47 45N, long 116 45W). Also set adrift was the LCI 713, a 1944-vintage troop landing vessel. The two vessels are being renovated by separate organizations. They drifted 100 yards downstream and hung up on a dolphin pier. A ship's engineer, living on the cutter, tied the vessels to the dolphin and they were towed to their mooring late Monday. At first that appeared to end the incident. Then water poured in near the rudder of Alert and three holes were spotted in the hull. After working all night, the holes were stopped up in the morning. The fuel is now being pumped off. The volunteers used wooden plugs, foam and anything they could stick in the holes. The leakage is still about five gallons a minute, but that is being handled by pumps. A crew remained on board, maintaining a 24hour watch, while a dry dock is sought where the vessel can be repaired. Alert will need a tug to get to the dry dock. The damage is just forward of the propellers and if the vessel went under its own power it would blow out the patches. The patching is only temporary. Alert was to be used by Sea Cadets for voyages along the river.

ALEUT (Cambodia)

Portsmouth, UK, Mar 23 — Vessel Aleut and an oil skimmer vessel collided late yesterday while entering Taganrog port. The oil skimmer was damaged, and leaked about 400 litres of oil-polluted water and oil products. Another oil skimmer deployed booms to prevent the contaminated water from spreading. Most of the oil has been collected and clean-up work is continuing at the scene. There were no injuries. An investigation into the incident has been launched. The Emergencies Ministry's regional centre said there was no threat to the environment from the incident. -Correspondent.

ALEXIA M. (Cyprus)

London, Mar 29 — Bulker Alexia M. arrived Batumi Mar 26.

AMER HIMALAYA (Cyprus)

London, Mar 23 — Following received from Coastguard Dover MRCC, timed

1315, UTC: Refrigerated general cargo Amer Himalaya (9070 gt, built 1990), Balboa for Sheerness with fruit, is currently reported not under command and drifting in lat 51 05.28N, long 01 37.78E, while investigating water in the cylinder head, possibly due to a cracked liner. Estimated duration of repairs three hours. Tug/supply Anglian Princess tasked and proceeding.

London, Mar 23 — Following received from Coastguard Dover MRCC, timed 1652, UTC: Tug/supply Anglian Princess has entered into tug contract to take refrigerated general cargo Amer Himalaya in tow for Sheerness.

London, Mar 24 — Following received from Coastguard Dover MRCC, timed 1055, UTC: Refrigerated general cargo Amer Himalaya berthed at Sheerness in tow of tug Anglian Princess this morning, after problems with cyclinder No.6.

Dover, Mar 27 — Refrigerated general cargo *Amer Himalaya*, Valparaiso for Sheerness and Rotterdam with a cargo of fruit, experienced main engine problems at about 1700, Mar 23, while passing Dover, inbound to Sheerness. The vessel's owners arranged for tug/supply Anglian Princess to tow the vessel to the Medway Buoy, after which two local Adsteam tugs assisted it to the berth in Sheerness, where it arrived alongside No 3 berth at 0700, Mar 24. The vessel's Sheerness cargo was discharged Mar 25-26, with the Rotterdam-bound cargo remaining on board. The vessel shifted to No 10 layby berth at 1400, Mar 25, to undertake repairs. Understand several piston crowns will have to be replaced and a new cylinder liner will arrive at Sheerness on Mar 28. Understand the earliest completion of repairs is envisaged to be pm, Mar 29. - Lloyd's Agents.

AMERICAN CONSTITUTION (Panama)

London, Mar 24 - A press report, dated Mar 23, states: Several people are in the hospital today, after tug/supply American Constitution (951 gt, built 1974) caught fire in position lat 29 54.57.69N, long 93 53.19.54W, near the port of Port Arthur, shortly after 1100 hrs. American Constitution caught fire below the deck. Port Arthur fire officials said the crew was welding when the bunk quarters insulation caught fire. Officials said three people were transported to a local hospital for smoke inhalation and two were treated on the scene. The vessel was being worked on at R and R Marine and housed a dive team who work on rigs.

AMERICAN PRIDE (U.S.A.)

London, Mar 23 — Following received from Coast Guard San Juan, timed 1540, UTC: Ferry American Pride remains aground in the same position. Salvage operations should commence today.

London, Mar 26 — Following received from Coast Guard San Juan, PR, timed 1355, UTC: Ferry American Prideremains aground at St. Thomas, US Virgin Islands. Up until now, no

refloating operations have been carried out and owners and salvors are still working out a salvage plan. The starboard fuel tank has now been emptied following the leakage from the port tank, which has since been contained.

London, Mar 28 — Following received from Coast Guard New Orleans, timed 1440, UTC: Ferry American Pride is still aground. Due to bad weather salvage operations have been suspended for the next three days.

ANDRINA F. (Antigua & Barbuda)

London, Mar 23 — A press report, dated today, states: The Maritime and Coastguard Agency will contact the owner of fishing (general) Zeldenrust that sparked a full-scale emergency after colliding with general cargo Andrina F. in the English Channel and then disappearing from the radar. Fearing the worst, the authorities launched a rescue mission before Zeldenrust was traced well away from the scene, apparently undamaged. Andrina F. diverted to Ramsgate with a two metre hole in its hull. The MCA will take witness statements and work with Belgian authorities to find out why *Zeldenrust* left British territorial waters without reporting the collision.

London, Mar 26 — According to Lloyd's MIU AIS, general cargo Andrina F. has now sailed Ramsgate and was located 12 miles off Terschelling at 1132, UTC, Mar 25.

Dover, Mar 26 — General cargo Andrina F. completed repairs and sailed Ramsgate Mar 24. — Lloyd's Agents.

ANGELA STAR (Panama)

Durban, Mar 29 — Bulkers Angela Star and Theareston are currently alongside at the DORMAC repair quay, Durban. It can be seen that the Theareston is effecting repairs to its upper hull bow plating, starboard side, however it is not known what damages each vessel sustained or how long repairs will take. — Lloyd's Agents.

ANTILLES II (Panama)

London, Mar 28 — Following received from Coast Guard Miami, timed 1455, UTC: Bulker Antilles II (7265 gt, built 2001), cargo phosphates, lost power and was deliberately grounded in lat 27 37N, long 82 39W, at 0930, UTC, Mar 27, in order to avoid colliding with the Sunshine Skyway Bridge, Tampa Bay. The vessel remains aground. No damage or pollution reported.

London, Mar 28 — A United States Coast Guard press release, dated today, states: The US Coast Guard is investigating the grounding of bulker $Antilles \ II$ about 400 yards east of the Sunshine Skyway Bridge, in Tampa Bay, after the vessel reportedly lost main propulsion about 0500, Mar 27. Two 25-ft response boats and a 41-ft boat from Sector St.Petersburg responded to the incident and the Coast Guard Captain of the Port established a safety zone restricting vessel traffic in the main shipping channel of Tampa Bay. Vessel traffic from Port Manatee to the Eggmont

Channel is closed to inbound and outbound traffic. Vessels travelling north of Port Manatee are not affected by the safety zone. Additionally a 100yard safety zone is in place around Antilles II. No injuries, pollution or damage to the bridge were reported in conjunction with the incident. Antilles II is reported to have a cargo of 10,000tonnes of phosphate, 78 tonnes of fuel and 20 litres of lubricating oil on board. The ocean bottom in the area where Antilles II grounded is reported to consist of limestone, oyster beds and mud. Coast Guard Sector St. Petersburg Command Centre received a call at about 0500 hrs from a Cooperative Vessel Traffic System (CVTS) watchstander, reporting that Antilles II was aground south of the shipping channel. Coast Guard marine inspectors and investigators will investigate the incident to determine the causes of the grounding.

London, Mar 28 — Following received from Coast Guard Miami, timed 1646, UTC: Bulker Antilles II is still aground. No hull breach is reported as the vessel grounded on soft bottom. Tugs are currently carrying out refloating operations.

London, Mar 28 — Following received from Coast Guard Miami, timed 2103, UTC: Bulker *Antilles II* was refloated at approximately 1800, UTC and is moored at Port Manatee.

London, Mar 28 — A press report, dated today, states: A ĥarbour pilot, this morning, decided it was safer to run bulker Antilles II into the ground, rather than taking the risk that it could smash into the Sunshine Skyway bridge, according to an official who spoke to him. Harbour Pilot Tobias Rose was on board the vessel this morning, to help manoeuvre it out of Tampa Bay. The ship lost both propulsion and steering, said Allen Thompson, executive director of the Tampa Bay Pilots Association. That left the vessel drifting toward the mouth of Tampa Bay. It was prudent to put the vessel aground on a sandbar on the south side of the shipping channel rather than taking the risk of running into a hard object like a bridge support. The vessel was dislodged from the sandbar early this afternoon and is being towed to Port Manatee for an inspection. Crews from tugs and the U.S. Coast Guard capitalised on a high tide as they worked to free the vessel. Coast Guard officials are continuing to investigate the incident. Water traffic has been diverted from the shipping lane from Port Manatee to the Egmont Channel. No injuries, environmental damage or damage to the vessel have been reported.

London, Mar 29 — A press report, dated today, states: Bulker Antilles II, that ran aground near the Sunshine Skyway Bridge early yesterday morning, was being assessed for damage at Port Manatee. "I would anticipate that they would do further inspections today and tomorrow," Port Manatee Executive Director David McDonald said yesterday afternoon. No one was injured and no environmental damage resulted from the ship running

aground, U.S. Coast Guard officials said. Tugs, taking advantage of high tide, managed to refloat Antilles II around noon and escorted it to Port Manatee for inspection. Shortly afterward, the shipping channel was reopened to traffic. Initial reports were that the master of the ship, which was heading to the gulf from the Port of Tampa, intentionally ran the ship aground to avoid hitting the bridge. "That's still under investigation," said Coast Guard spokeswoman Petty Officer Tasha Pully. investigating exactly why he grounded it and what the circumstances were that were involved." Pully said an investigation into the incident could continue for several weeks. McDonald said ship traffic to and from Port Manatee was minimally impacted and schedules were expected to be back to normal by yesterday evening.

ANZHELA EXPLORER (U.S.A.)

London, Mar 28 - A press report, dated yesterday, states. A boat crew from Coast Guard Station Fort Lauderdale, Fla, rescued three people from the 93-foot catamaran, yacht Anzhela Explorer (95 gt, built 1986), at around 0530 hrs, after the vessel began sinking half a mile off Hollywood Beach, Fla. The vessel's crew were unable to deploy the vessel's liferaft and were clinging to the bow of the vessel as the Coast Guard assets arrived on scene. The three people were transferred off the boat safely. The vessel sank in 23 feet of water. The Coast Guard has issued a Broadcast Notice to Mariners reporting the submerged vessel's location. There are currently 4,000 gallons of diesel fuel contained with the Anzhela Explorer and minimal sheening has been observed by Coast Guard inspectors. The Coast Guard is monitoring the owner's salvage and pollution efforts. The vessel's owners have hired SeaTow as their salvage contractor and have scheduled salvage efforts for tomorrow, when appropriate salvage equipment will become available. Commercial salvage divers examined the vessel area and have not found any indication of further contamination. The cause of the sinking is not known at this time.

London, Mar 28 - A press report, dated Mar 27, states: A salvage company plans to use a "big balloon" to refloat catamaran yacht Anzhela Explorer, that sunk off Golden Beach earlier this week. The 93-foot vessel sank yesterday morning about a mile offshore when the exhaust pipes broke off and water started flooding in through the opening. Three men on board were rescued by the Coast Guard. A video taken this morning, one full day after the sinking, shows the vessel completely submerged in the water. Sea Tow, which has been contracted to salvage the vessel, plans to inflate a rubber bladder inside the sunken vessel Thursday (Mar 29) in hopes of raising it to the surface. The \$2.2 million vessel reportedly belongs to Connally Yacht Service, a charter service based out of Puerto Rico. According to the company's website, the vessel's three decks can accommodate up to 30 overnight passengers.

APL CORONADO (Antigua & Barbuda)

Balboa, Mar 23 — General cargo APL Coronado appears to have been renamed Doris and according to Panama Canal records, sailed from Balboa at 0925, Mar 19. — Lloyd's Agents.

ASIA STAR (Panama)

Yokohama, Mar 26 — Passenger ro/ro Asia Star (3646 gt, built 1991) had to anchor in Tokyo Bay when a safety device, perceiving the falling oil pressure of lube oil for the main engine, cut in on Mar 16. The device was restored and the vessel resumed its voyage for Inchon. — Lloyd's Agents. (Note — Asia Star sailed Tokyo Mar 16 for Inchon.)

ATLAS AMELIA (Liberia)

Liverpool, Mar 23 — Bulker Atlas Amelia (25190 gt, built 1997) struck the quay at Liverpool Mar 22. The extent of damage is not presently known. — Lloyd's Agents. (Note — According to Lloyd's MIU AIS, Atlas Amelia was still in port at Liverpool at 1105, UTC, Mar 23.)

Liverpool, Mar 28 — Bulker Atlas Amelia sailed Mar 27 after effecting temporary repairs. — Lloyd's Agents. (See issue of Mar 26.)

BALTIYSKIY 102 (Russia)

Portsmouth, UK, Mar 26 — General cargo Baltiyskiy 102 (1926 gt, built 1978), cargo wood, ran aground 70 km west of Tallinn, with the reference to the chief of St. Petersburg the Sea Rescue Coordination Centre of Leonid Belov. The grounding was a result of navigation error. — Correspondent.

London, Mar 27 — Following received from Tallinn MRCC, dated today: General cargo Baltiyskiy 102, with a cargo of forest products, grounded in lat 59 20 45 N, long 23 31 27E, at 0108, Mar 25. There was no water ingress and oil leakage was reported. Vessel was refloated by tug Tasuja today after offloading some of the cargo. After reloading cargo, the vessel is to proceed to Paldiski harbour for inspection.

BEKA 1 (Cambodia)

CLIPPER TROJAN (Bahamas)

London, Mar 28 — A press report, dated today, states: Three companies that own and operate chemical tanker Clipper Trojan (9553 gt, built 1996) were indicted today in connection with an attempt by crew members to cover up the illegal dumping of oily waste in international waters, the US Justice Department announced. The 11-count indictment named Clipper Wonsild Tankers Holding A/S and Clipper Marine Services AJS, both of which are Danish companies, that operate and manage Clipper Trojan, and Trojan Shipping Co. Ltd., a Bahamas company that is the vessel's registered owner, as defendants. All three companies are part of The Clipper Group AlS, a global shipping consortium based in Denmark. According to the indictment, the vessel's crew members dumped oil sludge directly overboard on two occasions in May and June of 2006 and regularly dumped oil-contaminated bilge water overboard between March and June of 2006. Furthermore, crew members attempted to prevent the US Coast Guard from learning of the illegal discharges during an inspection of the vessel at Port Newark on Jun 15. 2006. According to the indictment, the vessel's chief engineer failed to record discharges in the vessel's oil record book and included false entries in the book that were intended to mislead the Coast Guard. The chief engineer presented the false oil record book to the Coast Guard during the Coast Guard's inspection. According to the indictment, the chief engineer made several false statements to Coast Guard inspectors and encouraged other crew members to lie to the Coast Guard

as well. The indictment alleges that the crew members acted as agents for the corporate defendants attempting to cover up the illegal discharges of oily waste. It also alleges that the three companies failed to provide sufficient training to the crew and failed to diligently enforce company policies concerning the handling of oily waste. The indictment further alleges that the companies caused some crew members to execute affidavits falsely stating that the crew members had received briefings on the MARPOL Protocol, an international treaty regulating the handling and disposal of oil waste at sea and US laws concerning oil pollution. On Feb 2, 2007, Fernando Magnaye, of Quezon City, Philippines, who was the vessel's chief engineer, pleaded guilty to charges of presenting a false document to the Coast Guard and attempting to obstruct a Coast Guard inspection. During his plea hearing before US District Judge Mary L. Cooper, in Trenton, Magnaye admitted that he knew about illegal discharges of oil sludge and contaminated bilge waste but nonetheless failed to record those discharges in the vessel's Oil Record Book. Magnaye also admitted that he presented the false oil record book to the Coast Guard and falsely claimed to Coast Guard inspectors that the book was accurate. Mangaye further admitted that he asked the vessel's fourth engineer to fabricate a pipe that would ensure that the Coast Guard would take a false reading of the contents of the vessel's bilge sludge oil tank, in which oily waste was stored. The indictment charges each of the companies with one count of conspiracy, one count of violation of the MARPOL Protocol, one count of making and using materially false writings and documents, seven counts of obstruction of justice, and one count of concealment of a tangible object to obstruct an investigation. If convicted, the companies face statutory maximum fines of \$500,000 on each count or, alternatively, twice the amount of any gain to the corporations that inured as a result of the criminal conduct. The case is being prosecuted by Assistant US Attorney Bradley A. Harsch of the US Attorney's Office for the District of New Jersey and H. Claire Whitney, Senior Counsel for the US Department of Justice Environmental Crimes Section. The investigation was conducted by US Coast Guard Investigative Service.

COTE D'IVOIRIAN STAR (Panama)

London, Mar 27 — Refrigerated general cargo *Cote d'Ivoirian Star* sailed Agadir Mar 19 and subsequently arrived Abidjan Mar 24.

DOKKEN (Panama)

London, Mar 29 — Following navigation warning issued Mar 23: Combined chemical and oil tank *Dokken* (7498 gt, built 1982) lost anchor in lat 29 47.91S, long 31 05.93E. Danger to navigation. Vessels to give a wide berth until further notice. (Note — *Dokken* arrived Durban Mar 20, and sailed Mar 22.)

DOLPHIN 111 (Vanuatu)

London, Mar 22 - A Coast Guard Corpus Christi press release, dated Mar 21, states: Coast Guard personnel continue to monitor drill platform Dolphin 111 that is aground approximately one mile offshore and six miles south of the Port Aransas, Texas jetties. Workers are preparing for an underwater inspection of the rig. Divers will ensure the rig is not in need of any repairs prior to refloating it. The divers are expected to complete their inspection this evening or tomorrow morning. It was previously reported that the generators provided power for de-watering pumps. The generators that did not have fuel were for the ballast pumps that provide levelling capabilities. The rig crew had attempted to level the platform but were not successful.

London, Mar 22 — Following received from Coast Guard New Orleans, timed 2150, UTC: Drill plarform *Dolphin 111* is still in the same position. Owners representatives are assessing the situation and drawing up a salvage plan. Divers have not been able to dive today because of the bad weather.

London, Mar 23 — A press report, dated Mar 22, states: A salvage team from Houston is proceeding to the Port Aransas jetties to try and refloat drill platform *Dolphin 111*. The Coast Guard tried to stabilise the rig today, but it apparently has taken on more water than originally thought. The salvage team will try to plug up some of the vents that are letting the sea water in. Once that has been completed, they will try to drain and move the rig, but that may not happen until this weekend.

London, Mar 23 — Following received from Coast Guard New Orleans, timed 1550, UTC: Drill platform *Dolphin 111* remains aground. A salvage plan is being drawn up. (See issue of Mar 26.)

London, Mar 26 — Following received from Coast Guard New Orleans, timed 1400, UTC: Drill platform *Dolphin 111* remains aground south of Port Aransas. An improvement in the weather is awaited to enable a diver survey to be carried out in order to obtain approval of the salvage plan. Salvage equipment is due on scene today.

London, Mar 28 — Following received from Coast Guard New Orleans, timed 1430, UTC: Drill platform *Dolphin 111* remains aground. An improvement in the weather is awaited to allow salvage operations to commence.

DONG WON NO.212 (South Korea)

Tahiti, Mar 22 — Fishing (general) Dong Won No.212 towed to Tahiti following engine problems: Following information received from Papeete MRCC: On Mar 17 call received from Tahiti Fishing, local agent of Dong Won No.212, asking assistance for vessel. This call was confirmed by radio call with the vessel's capitain. Position was given and engine problem was reported. At 1710, Mar 17, French Navy tug RPC Maroa left Papeete and headed 300 Nq/North/Tahiti. At 0745, Mar 19, French Navy tug RPC Maroa

towed *Dong Won No.212* back to Tahiti. At 2045, Mar 21, convoy arrived at Papeete harbour. The manager of Tahiti Fishing and a technician report: "Parts for broken engine have been ordered in Korea and they are on the way to Tahiti. Members of the anti-bomb squad were observed sweeping the vessel soon after everyone on board was evacuated.

The vessel is now back in service after 24 hours intensive checking in which nothing has been found. The vessel sailed to Kumai, South Kalimantan, at about 1300, local time, Mar 27. — Lloyd's Agents.

EKARMA-2 (Russia)

London, Mar 29 — Fishing (general) Ekarma-2 (745 gt, built 1994) had a net entangled in its propeller in the Sea of Okhotsk Mar 27. EMERALD SEA

London, Mar 24 - A press report, dated today, states: Fishing (general) Emerald Sea (86 gt, built 1980), trawling for sardines off Newport Beach, ran aground early yesterday. The vessel, which cast off from San Pedro, apparently hit a sandbar near 36th Street about 0100 hrs, jolting the five-member crew. There were no injuries and no apparent damage to the steel-hulled vessel, which was stuck about a half-mile north of Newport Pier. Officials said a tug would attempt to pull the trawler off the sandbar at high tide early this morning. It's unclear why the Emerald Sea ran aground, though authorities said preliminary reports pointed to operator

London, Mar 24 — Following received from Coast Guard San Francisco, timed 1035, UTC: *Emerald Sea*, VIN 626289, refloated at 0143, local time, today. Vessel has a small crack in its keel and pumps have been placed on board. Vessel has moored to effect repairs. No pollution.

London, Mar 24 — A press report, dated today, states: A private tug crew pulled the grounded fishing (general) Emerald Sea into deep water shortly before high tide this morning. The sardine vessel was pulled off a sandbar shortly after midnight, according to a Newport Beach Harbour Patrol spokesman. Emerald Sea was examined by a US Coast Guard inspector, who determined that no damage to the hull was sustained in the accident, according to the Newport Beach Fire Department.

ENGLISH STAR (Bahamas)

Guayaqui, Mar 22 — During loading operations at Guayaquil port yesterday refrigerated general cargo English Star (10291 gt, built 1985) had a fire in at least one of its holds. A survey was conducted yesterday. — Lloyd's Agents. (Note — According to Lloyd's MIU AIS English Star was still moored at Guayaquil at 1804, UTC, today.)

Guayaquil, Mar 26 — Refrigerated general cargo English Star had a fire in hold No 3 at approximately 1006, Mar 21. Approximately 9,269 boxes of fresh green bananas were stored in the hold and were completely destroyed due to the heavy smoke the and sea water poured into the hold, which soaked the boxes. The most probable cause of the fire into the room of reefer was a short circuit in the electric cables of fan No 1 and/or in the electrical cables that feed the fans. There were no injuries, and no pollution was observed during or after the fire. — Lloyd's Agents.

ESTONIA (Estonia)

London, Mar 23 - A press report, dated Mar 22, states: Passenger ro/ro Estonia that sank Sep 28, 1994, in the Baltic Sea might have been carrying weapons, says a report drafted by a special commission of the Estonian government. The authorities published the document today. It says weaponry that Estonian officials knew nothing about might have been loaded into the vessel's holds. However, the report rejects claims *Estonia* had sunk after an explosion on board. "The ship wrecked due to construction flaws, a storm on high seas and excessive speed," it said. An official version of the tragic wreckage that claimed 852 lives was challenged by the Russian research and analysis group Feniks. Its experts claimed the ferry's crew might have been transporting some illegal cargoes like weaponry, drugs or precious metals. Apprehensions of exposure of the cargo might have prompted someone to get rid of it by throwing it overboard and this was exactly what led to a disaster on the stormy night, Feniks experts surmised. Another story published in the Estonian media suggested that Estonia had twice carried some Russian defence equipment to Swedish secret services in September 1994. (Note — Estonia had engine breakdown in stormy weather and subsequently capsized and sank about 20 miles south-south-east of Uto pilot station, in lat 59 23N, long 21 42E, 28 September 1994, after the bow door was torn off when a locking device failed. 989 persons on board, 137 survivors.

EVELYN MAERSK (DIS)

Copenhagen, Mar 28 — Port of Odense confirm that container carrier Evelyn Maersk experienced engine problems during sea trials which commenced on Mar 17. The vessel was thereafter riding at anchor for two or three days until the problem was solved. A bearing in the fuel supply had burned out. Understand that sea trials are still being performed. — Lloyd's Agents.

Čopenhagen, Mar 28 — Container Carrier Evelyn Maersk arrived at Aarhus at 0630, local time, Mar 26 and is due to leave on Apr 7. — Lloyd's Agents.

EXCELSIOR

London, Mar 27 — Following received from Kiel, dated today: Operations to raise 14 sunken containers from general cargo Excelsior re-commenced today. Three sheerlegs were ordered to the site from the lower Rhine and South Germany, for this purpose. The remaining two containers with dangerous goods are to be raised first. The one which was salvaged yesterday has been placed and secured on the Rhine shore. The river is closed to shipping over a length of 20 kms, between Colgne-Zundorf and Cologne-Niehl. More than 200 vessels are now waiting for passage.

London, Mar 28 - Information received from Kiel, dated today, states: Eight of the containers lost from general cargo *Excelsior* have so far been salved from the bottom of the Rhine. Strong currents are making the work difficult and dangerous. The intention is to open the Rhine, at least partially, on Mar 30. Prosecutors in Duisburg have not yet decided whether to continue the investigations of the vessel in situ, or whether to tow it into a yard. A total of 32 containers fell into the river, one more than originally thought. Salvage work is concentrating on one container with dangerous goods which is lying close to the shore, along with the containers which sank directly in the shipping lane. A container holding 68 barrels of dangerous goods which had already been salved by the Fire Brigade has been emptied. None of the barrels was damaged. Fifty-two firefighters, 39 Technical Support workers and six members of the Bayer Fire Brigade were on the scene from Mar 27-28.

London, Mar 29 — Following received from Kiel, dated today: Salvage work to recover containers lost by general cargo *Excelsior* continues today. Sixteen of the 32 containers lost have been recovered to date, including the three which contained dangerous goods. When the third container with dangerous goods was raised most of the acid carried in barrels had been lost and it was in danger of breaking in two. The acid in the second container, successfully salved yesterday, was

safely unloaded and transported to a special firm, by lorry. The first of the three was recovered from close to the South bridge in Cologne without problems. Three containers are presumed to be directly beneath Excelsior. Four vessels are searching for actual container positions this morning. The sunken containers change positions, due to the current. A fourth salvage vessel from Mannheim is to support the recovery works from today. Also today, the remaining cargo on board Excelsior is to be secured and the ship will proceed to Niehl, where the remaining containers are to be unloaded. Meanwhile 500 vessels are delayed, waiting for passage.

EXCELSIOR (Germany)

Portsmouth, UK, Mar 25 — Earlier today, general cargo *Excelsior* (2,878 gt, built 1986), lost 30 large containers on the River Rhine at Cologne. The river police warned shipping of the danger of possible floating containers in the area, but some have already sunk. Shipping has been stopped at Cologne. — Correspondent.

London, Mar 26 — Following received from Kiel, dated today: At 1430 hrs, Mar 25, the German inland general Excelsior,homeport Stuttgart Neckarsteinach, Rotterdam, with 103 containers, lost about 31 containers in the Rhine, close to Cologne. The ship had sustained water ingress in the forepart and had unsuccessfully tried to turn around. The master had intended to anchor, but the vessel stuck fast on the right bank and developed such a list that the containers on deck fell into the water. The cargo was drifting downstream, so the river was closed between km's 675 and 678. Up to 1930 hrs, some 30 ships travelling downstream and 20 in the opposite direction were affected by the river closing. The ship remained listing and in danger of capsizing. Several rescue teams are on scene. Some of the 40-ft-boxes sank. Twenty-five have been traced and secured. They will be salved tomorrow.

London, Mar 26 — Following received from Kiel, dated today: Three of the containers lost from general cargo Excelsior contained dangerous goods. Two of them have been found, the third is still missing. Police forces, supported by helicopters, have currently found 17 containers, which have been salved. Fourteen are presumed to be sunk. The will have to be traced with sonar and then raised with a sheerleg. It is now anticipated that the River Rhine may be closed until Mar 28, at least.

London, Mar 26 — Information received from Kiel, dated today, states: The containers lost from general cargo Excelsior at Cologne on Mar 25 are spread over a length of 20 km, reaching the city of Cologne. The cause of the loss is still unclear. The vessel carried 2,630 tons cargo in 103 containers. The last six containers were traced this afternoon, among them one containing a substance for mordanting. The salvage work first concentrated on the three containers loaded with dangerous goods. One, which carried 22 tons of

fuel addition, was first righted and then pumped out by firefighters. A small quantity of the contents leaked into the Rhine. The other two containers will be raised next. Two contracted salvage companies will commence the salvage of the other 28 containers on Mar 27. Fourteen containers have sunk in the traffic lane, and 17 others close to the shore. Three specially equipped salvage vessels are expected to arrive early Mar 27. Meanwhile, 100 vessels are waiting for passage up-anddownstream and have, as a precaution, partially berthed some distance from Cologne. The river closure could last up to Mar 29, although it will hopefully be at least partially reopened before then.

London, Mar 27 - A press report, dated Mar 26, states: A 12-mile stretch of the Rhine river was closed to shipping on Monday (Mar 26) as authorities in Cologne tried to locate several large metal containers that fell off general cargo *Excelsior* over the weekend. The vessel, lost 31 containers on Sunday afternoon. Several fell off when the vessel listed; the rest spilled when the master swung the vessel round in an attempt to recover the lost cargo. Twenty-five of the containers had already been recovered on Monday but police were still searching for the other six, which had likely sunk and could pose a threat to other shipping. The stretch of the river around Cologne was expected to remain shut down through Wednesday, police said. Some 100 vessels were already backed up awaiting its reopening. None of the containers was believed to contain anything that could cause significant environmental damage.

London, Mar 28 - Information received from Kiel, dated today: The salvage of the 31 containers which were lost by general cargo Excelsior on the Rhine proceeded on Mar 27. In the midday hours the sheerleg Grizzly and the diver support vessel Carl Straat, homeport Duisburg, arrived as well as a crane which started work at Porz-Ensen where several containers ran aground or sank. Seventeen containers were secured by fire brigade, 14 have sunk in the traffic lane. All positions are known, but the current may move the containers. At Zuendorf a "diver's bell" was tried, which allows fixing the ropes while working directly on the sunken container. The salvage of the first container here lasted longer than expected as the 20 tons of corn inside now had a weight of 60 tons after water ingress. Grizzly raised the container at 1730 hrs and placed it onto a pontoon. More difficulties were faced in Ensen. One of the slightly damaged containers with chemicals collapsed in the middle when being raised by the crane Kraanvogel. It could only be taken to the shore and not on to a vessel as planned. A Rhine ferry should take the container in the evening hours into the harbour of Niehl. Therefore the second container with dangerous goods can only be salved on Mar 28. On the whole six containers were salved up to the morning of Mar 28.

London, Mar 29 - A press report, dated today, states: The Rhine will probably reopen to traffic tomorrow as rescuers clear the river of containers that fell off general cargo Excelsior near Cologne at the weekend. "It's looking more and more like we will open as hoped tomorrow," Markus Lehmacher, a spokesman for Cologne's Water and Shipping Agency, said today. 'We don't completely rule out opening it today if we can be sure the shipping channel is completely safe." Ships may be allowed to resume passage even if some containers remain in the water, Lehmacher said. Some 16 containers that slid into the water were recovered by yesterday, he said. Another nine have not yet been retrieved. BASF AG, the world's largest chemical maker, said it may redirect raw-material shipment en route to Rotterdam and Hamburg to truck and rail transport, spokeswoman Saskia Ziegelmaier said vesterday. She said the company, based in Ludwigshafen on the banks of the Rhine, had experienced effects" from the blockage. `limited

EXODUS EXPLORER (U.S.A.)

London, Mar 22 - A press report, dated today, states. Fishing Exodus Explorer, loaded with 35,000 pounds of cod, has sunk at Adak Island and the U.S. Coast Guard is investigating. The vessel sank in six fathoms of water Sunday (Mar 18) after running aground on Gannet Rocks in Kuluk Bay, at about 0200 hrs, while heading into nearby Adak harbour, according to the Alaska Department of Environmental Conservation. Aside from fish, the vessel was also carrying 2,500 to 3,000 gallons of diesel. A boom was placed around the vessel to contain a spill. The vessel is about 100 yards off the beach, capsized, with the stern sticking out of the water. The owner, B&N Fisheries Co. of Seattle, and Capt. Dan Carney have prepared a salvage plan, the DEC reported today.

EXPLORER (Antigua & Barbuda)

Bilbao, Mar 22 — Understand from ship's agents at Requejada that general cargo *Explorer* loaded a shipment of sodium carbonate at Requejada and when leaving the port Mar 16, grounded on a sand bank. The vessel was refloated on Mar 18 with the high tide and the assistance of tugs. *Explorer* was inspected by class (Germanischer Lloyd) with the aid of divers and no damage was noted to the hull. The vessel sailed from Santander on Mar 21 bound for Casablanca. — Lloyd's Agents.

FAGERVIK (Antigua & Barbuda)

London, Mar 23 - A press report, dated Mar 22, states: The Coast Guard Drug and the Enforcement Administration announced a record seizure of 42,845 pounds of cocaine on board general cargo Gatun (3241 gt, built 1970) on Sunday (Mar 18) off the coast of Panama, A Coast Guard C-130 spotted Gatun approximately 20 miles south-west of Isla de Coiba, Panama, on Saturday. It received consent to board the vessel through a maritime agreement between the United States and Panama. A search team discovered the cocaine hidden in two containers on board the ship. Fourteen Panamanian and Mexican crew members were arrested and were transferred to the United States and Panama for prosecution. DEA Administrator Karen Tandy said: "This weekend Mexican drug traffickers were awaiting the arrival of 19 tonnes of cocaine that is now in the hands of U.S. law enforcement instead of the hands of drug traffickers and abusers." The cocaine has an estimated value of \$300-million."

Balboa, Mar 28 — General cargo Gatun was detained by the United States Coast Guard and is presently at Balboa anchorage. Press reports indicate that 19.5 tons of cocaine were seized on board. The vessel is said to be under the custody of the Panamanian government at this time. — Lloyd's Agents.

GOLDEN SKY (Cyprus)

There were no fatalities. The vessel was undergoing repairs when the fire occurred, Coast Guard officials said. The cause of the fire is still to be determined. — Lloyd's List Correspondent.

London, Mar 27 — A press report, dated today, states. The head of the Philippine Coast Guard led a team, yesterday, that will assess the oil spill caused by general cargo Harpoon, a senior official said. The vessel caught fire while undergoing repairs in a shipyard in Cebu. Fishermen in Toledo City have been complaining that an oil slick has started to damage their fishing nets said Coast Guard spokesman Armand Balilo. The vessel caught fire at 2200, Mar 24. The fire was extinguished by 0300, Mar 25. Fishermen in Sto Nino village noticed the oil spill at 0600, Mar 25. "The ship might have leaked as a result of the fire, which started in vessel's engine room," said fire officer Ben Diotay. The spill spread out over a 150-metre radius, and has affected 11 coastal villages, said Haile Baron, village chief of Sto Nino village. The oil spill has reached a beach near the city cemetery and a private resort in Matab-ang village in Toledo City, said Baron, adding that marine life and livelihood in these areas will be totally endangered if nothing is done about the oil spill. "Dead fish have begun floating in our seas," said Toledo City Mayor Arlene Zambo, adding, "The situation has worsened.

Manila, Mar 28 — An oil slick, which threatened Toledo City and five coastal villages on Cebu island, central Philippines, has been traced to general cargo *Harpoon*, which caught fire while undergoing repairs at Tsuneshi Heavy Industries (Cebu) Inc shipyard. Reports indicate that the oil spill occurred when a fire broke out in the engineroom of the vessel on Friday evening (Mar 23) while it was drydocked at one of the yard's floating docks located about 20 metres from shore. The

bunker fuel escaped from the floating dock into the surrounding waters when firemen smashed a hole in the ship's hull to gain access into the engineroom. About 250 litres spilled into the sea before oil spill booms could be laid around the floating dock. Tsuneishi officials said that the oil spill had been placed under control by Monday as shipyard workers applied dispersants and laid oil spill booms around affected coastal areas. - Lloyd's List Correspondent.

Rescue workers were still looking for the missing sailors last night but officials said it was unlikely they had survived. The 10,000-ton Korean cargo vessel was leaving Baoshan Port bound for Pusan in South Korea when it collided with the smaller Chinese general cargo Meisheng 3698, which was arriving from Nanjing in Jiangpu Province with five crew onboard. The Chinese vessel quickly capsized after the collision, officials said. Maritime rescuers said they pulled two sailors from the water within $10\ minutes$ of the collision, but were unable to locate the three other crew members. The identities of the missing crew have not yet been disclosed. The cause of the accident is still under investigation, but authorities said they had ruled out visibility problems, because conditions were clear at the time of the collision. The Korean vessel has been ordered to anchor at a local port to assist in investigations. Attempts by salvage operators to raise the ship were ongoing yesterday and it still lies in the water near the banks of the river. Small vessels that navigate the waterways near the banks were forced to divert to avoid the capsized ship, according to maritime officials.

The Coast Guard said they received a call about *Miss Rutha*, drifting towards Miami Beach just before 1000 hrs today. According to their report, the crew members remained on board and they were not notified that the ship was in distress. A commercial salvage tug joined up with Miss Rutha about 1015 hrs. The crew of the tug is trying to re-direct it back out to sea. The Coast Guard says that one of the reasons that may have contributed to the ship getting loose from its anchorage is the higher than normal wind and rough seas.

Damage is being investigated.

London, $\bar{\text{Mar}}$ 28 — According to Lloyd's MIU AIS, roll on roll off MN-Pelican was located stationary at La Pallice as of 1037, UTC, today.

MSC ERMINIA (Panama)

London, Mar 22 — Container Carrier MSC Erminia arrived Antwerp 1921, Mar 21 and according to Lloyd's MIU AIS was still stationary in lat 51 19 32N, long 04 20 11E, at 1831, UTC, today.

Zeebrugge, Mar 23 — Container Carrier *MSC Erminia* encountered steering problems on the River Scheldt and was towed to its berth. The problem has already been solved and the vessel sailed this morning. -Lloyd's Sub-agents.

MSC NAPOLI (U.K.)
London, Mar 23 — A press report, dated today, states: Container carrier MSC Napoli was carrying more than 1,500 tonnes of toxic chemicals including battery acid, a banned pest killer and a substance which can affect human hormones. The owners of the vessel have refused to publish full details of what she was carrying. In the wake of the accident officials only confirmed that 1,552 tonnes of chemicals were being transported, but would not give details of what they were. However, under the Freedom of Information Act, the Coastguard and Maritime Agency (MCA) has now been forced to reveal the full inventory of the chemicals. The list includes 81.5 tonnes of battery acid, 60 tonnes of hazardous phosphorous, 36 tonnes fluorocarbons - a chemical found inside fridges - and 42 tonnes of methyl bromide - a pest killer banned in most countries. Although none of the chemicals leaked into the sea, environmental groups say it was a "miracle" the accident didn't turn into a major environmental catastrophe. Dr Paul Johnston, of Greenpeace, said: "The chemicals were packaged in drums and tanks, but they can only take so much punishment, as we saw with the non-hazardous containers which came ashore. If these chemicals escaped there would have been a significant environmental impact. It would have been a disaster for sea life if the weather had been worse. Methyl bromide in particular is very nasty. Kids could have tampered with a container and gassed themselves and there would have been dead fish and birds everywhere." MSC Napoli was carrying 42 tonnes of methyl bromide a pest killer banned in most developed countries because it depletes the ozone layer and can cause convulsions and nausea. The vessel also held 2.5 tonnes of carbendazim, a substance listed on Friends of the Earth's 'filthy four' list

of pesticides because of fears it can disrupt hormones. In total, 159 containers of hazardous goods were on board the vessel when she was deliberately beached. Officials say 84 of them have been lifted off. Two, containing nitric acid and car air bags, were washed ashore, but the substances did not get released. Now just 75 remain below deck of the vessel. An MCA spokesman said all the hazardous chemicals were packaged in accordance with United Nations guidelines. She said: "There were 159 containers with hazardous goods in them, but some containers carried more than one substance, hence there are more entries on the list than containers. All dangerous goods are required to be cased in UN-approved packaging in order to minimise accidental release."

London, Mar 26 - Every container removed from the beached Container Carrier MSC Napoli is being weighed, opened and the contents examined, as investigators search for evidence of undeclared or misdeclared hazardous cargo. The inspections are being carried out by the Maritime and Coastguard Agency in parallel with the main accident enquiry that the UK's Marine Accident Investigation Branch is conducting and could result in prosecutions. Those charged would probably be the consignors, although the cargo screening systems of Mediterranean Shipping Co are also likely to be scrutinised, if large quantities of wrongly labelled dangerous goods or over-heavy freight are found. It is a criminal offence in the UK to not declare dangerous substances and could lead to jail sentences, Captain Jeremy Smart, the MCA's principal enforcement officer, is reminding shippers. Never before has a regulatory agency had such an opportunity to discover exactly what is carried in a container and whether it matches the official description. Most major containership casualties have involved fire, explosion or grounding in relatively inaccessible areas, and often involve vessels flying an international flag. MSC Napoli, in contrast, is a British-registered, managed by Zodiac London-headquartered Maritime Agencies and now aground off the south of England.

MTS CHRISTA (Netherlands)

Portsmouth, UK, Mar 24 - Non specific tanker MTS Christa (730 gt, built 1962) was in collision with tug Willem Laurentz with three barges, at 1930 hrs, Thursday (Mar 22) on the Albert Canal, off Meerhout. The tanker, which was loaded with fuel, sustained a leak, however, no fuel ended up in the canal. Shipping movements on the Albert Canal were unaffected by the collision. — Correspondent.

MYRA (Bahamas)

Georgetown, Guyana, Mar 22 — General cargo *Myra* arrived with a consignment of soya which the public health stated was contaminated with salmonella and should not be offloaded. However, the consignee went to

the courts, who overruled the public health authorities and said that the consignment be discharged. Today when the vessel was about to discharge, a countermove was made staying the discharge. The vessel is now at anchorage awaiting further proceedings. This morning when the vessel was first expected to discharge, the consignee requested a discharge survey including sampling. - Lloyd's Agents.

London, Mar 26 — A press report, dated Mar 25, states: The Guyana Revenue Authority (GRA) is unchanged in its position against the release of 900 tonnes of soya feed contaminated with salmonella typhimurium, which is on board the general cargo Myra, moored midstream of the Demerara River. On Wednesday (Mar 21) the importer failed for a second time to move the vessel upstream to a facility located 10 miles up the Demerara River from Georgetown. A High Court judge had ordered the GRA to release the contaminated soya aboard the Myra after the importer moved to the courts to seek to enforce an earlier order issued by another judge. However, the order of the court conflicts sharply with instructions issued by the Ministry of Agriculture's Quarantine Department. Government spokesman, Dr Roger Luncheon said that the Agriculture Ministry had been mandated by Cabinet to defend the public health of the nation. According to sources, the soya feed was transiting Guadeloupe when the laboratory tests were done. It is believed that the feed was meant for Guadeloupe's poultry industry and after it was found to be defective it was being sent back to Europe to be destroyed. However, the Bahamianregistered ship made its way to Guyana. The GRA has refused several requests to release its hold on the ship, including one made by the Ministry of Agriculture to take samples of the feed onboard for testing. French health authorities have specifically advised that the hold not be opened under the tropical conditions that currently exist. The Customs and Trade Administration is insisting that the cargo be returned unopened to France, from whence it originated.

MYS LEVENORNA (Russia)

"Everything depends on the results of our inspections of the ship, but the fact that it returned all the way to Japan on its own suggests there aren't major machinery problems," he said. After the fire broke out, the environmental group Greenpeace offered to tow the stricken Nisshin Maru with its anti-whaling vessel Esperanza, but Japan declined, saying it could get help from nearby Japanese vessels if necessary. Esperanza is set to arrive in Tokyo on Mar 28, where Greenpeace will invite officials from the Fisheries Agency and the Institute for Cetacean Research on board. — Reuters.

However it is now known that since that date at least 20 litres of fuel oil has been escaping a day. The Cabinet yesterday decided to call on the petrol company to carry out a new inspection to establish the seriousness of the problem.

London, Mar 27 — A press report, dated today, states: Investigators will dive more than 3,500 metres to the wreck of crude oil tanker Prestige this summer to check how much oil is leaking out of the vessel, which sank off Spain's north-west coast in 2002. The Spanish government said oil company Repsol would do a visual check of the seabed where the vessel is lying and see what state its hull is in.

QUEEN OF THE NORTH (Canada)

London, Mar 27 - A press report, dated Mar 26, states: Just before passenger ro/ro Queen of the North crashed into a remote island, the ship's fourth officer ordered the quartermaster to switch off the autopilot and make a radical course correction, a B.C. Ferries investigation has found. For a split second, the quartermaster questioned the order. until she saw the trees. Then she said she searched for the switch to turn off the autopilot. She could not find it. As she fled the bridge deck to alert the ship's master of the emergency, she told investigators she heard the fourth officer tell the second officer: "I'm sorry I was trying to go around a fishing boat." New details of what went on on the bridge of the ferry on the night of Mar 22, 2006, were outlined by B.C. Ferries investigators in a report released today. The report sheds some light on the chaos that erupted in the minutes before and after the vessel crashed in Inside Passage. The report concludes the ferry left Prince Rupert under routine and uneventful circumstances and went down shortly after midnight because the fourth officer failed to make a course correction. "Human factors were the primary cause of the sinking of Queen

of the North," said the report. In part, it concludes the fourth officer "failed to make a necessary course alteration or verify such alteration was made in accordance with pre-established fleet routing directives and good seamanship." Why the experienced seaman, who had been working for B.C. Ferries since 1990, made the error is not explained. The report also concludes that the navigational watch failed to maintain a "proper lookout." Those who were on lookout maintained a "casual watch-standing behaviour," investigators determined, partly because music could be heard playing on the bridge during radio calls. The report also does not offer any answers why two of the 101 people on board the vessel did not make it to safety. "The divisional inquiry panel has been unable to establish the movement or location on the vessel of the two missing passengers," the report says. The fourth officer and the second officer, who are not named in the report, both refused to co-operate with B.C. Ferries investigators on advice of their lawyers. The quartermaster has also not been named in the report. However, they were identified in court documents filed by passengers suing B.C. Ferries.

SEA SPRAY (U.S.A.)

London, Mar 24 — A press report, dated yesterday, states: Tank barge Sea Spray (2244 gt, built 1966) capsized while leaving a dock, sending its load of 4,000 tons of scrap metal to the bottom of Commencement Bay. No one was

hurt and there appeared to be no ecological damage, the Coast Guard said today. The accident happened last night as the barge was leaving a dock at Schnitzer Steel Industries. The Coast Guard was investigating, Petty Officer Shawn Eggert of the Coast Guard's Seattle headquarters said. The barge was towed back to the dock today, and Schnitzer Steel officials were arranging to have the scrap metal salvaged, Eggert said. The Coast Guard issued a "notice to mariners" warning of the metal, which was located about 60 feet off the Schnitzer dock.

One of the bodies, which had decayed to the point of being barely recognizable, was taken to Kendari and placed in Southeast Sulawesi general hospital's morgue for further identification. A card found on the victim identified him. The head of the Kendari search and rescue office, Roky Asikin, said the other three bodies were taken to Kendari Monday and would soon be flown to Semarang, Central Java. The vessel sank off the Java Sea late December last year while on its way to Semarang.

SERVER (Cyprus)

London, Mar 29 — A press report, dated Mar 26, states: Ten weeks after the grounding of bulker Server at the Helisoy lighthouse, fuel oil still pollutes the local coastline from Selje to Agotnes. The collision occurred because Shinsei Maru No.3 had not avoided the course of Zim Asia, said Presiding Judge Kenichi Yonehara of the Yokohama Marine Accident Inquiry Agency in

handing down the ruling. But the judge refused to issue any advisory as requested by investigators that the agency urge both the owner of the Japanese ship and the master and a navigator of the Israeli vessel to take improvement measures with regard to their ships' lookouts and the emergency evacuation routes for crew members.

This plan was determined following a thorough inspection of the casualty, inclusive of a diving survey. Skarpoe was moved off the rocks about 0515, local time, today. Skuld then towed the casualty to nearby Hasle port anchorage for further inspections and stabilisation.

London, Mar 24 — A press report, dated today, states: Non specific tanker Solar 1: Despite causing the worst environmental disaster in the country, the Guimaras prosecutor's office has dismissed the criminal complaint filed against officials of Petron Corp "for lack of probable cause." The resolution penned by provincial prosecutor Luzermindo Calmorin stated that, while the oil spill caused environmental and economic havoc in Guimaras, particularly in the municipality of Nueva Valencia, "it does not follow that there is criminal liability involved." Guimaras officials are mulling the possibility of asking the Guimaras prosecutor's office to reconsider its decision to dismiss the criminal complaint against officials of Petron Corp for the oil spill. The complaint was filed against Petron officials Nicasio Alcantara, Khalid al-

Faddaq, Carlos Tan and two others for violations of the Clean Air Act, Clean Water Act and the Ecological Solid Waste Management Act. The Petron Corp chartered Solar 1, owned by Sunshine Maritime Development Corp, to transport two million litres of bunker fuel when it sank off Guimaras in August last year. Gov JC Rahman Nava and Nueva Valencia Mayor Diosdado Gonzaga will confer with provincial legal officer Plaridel Nava this coming week on their next course of action, the governor said today. "Probably we will ask the prosecutor's office to reconsider the dismissal of the complaint," he said. Following the incident, Gonzaga lodged the complaint in behalf of his municipality, which was considered the hardest-hit. Despite the dismissal, Gov Nava said that they would not give up and that they would continue to support Nueva Valencia. "That is why our provincial legal officer assisted them in the filing of the complaint," he said. Tan, Petron Corp's spokesman, said he had received his copy of the resolution and added that he was delighted that the Guimaras prosecutor's office agreed with them.

London, Mar 26 — A press report, dated today, states: The province of Guimaras will appeal the decision of the Guimaras Provincial Prosecutor's Office not to proceed with the criminal complaint against officials of Petron Corp and the owner of the sunken non specific tanker Solar 1. Guimaras provincial legal officer Plaridel Nava II said they would file a motion for reconsideration tomorrow. Nava said that while they agreed with the resolution that the sinking of the vessel and the oil spill were unintentional, they would point out that Petron and the vessel's owner were still criminally liable for reckless imprudence. He said that the vessel was already not seaworthy on Aug 11 when it sank 13.3 miles south-west of Guimaras Island. Nueva Valencia Mayor Diosdado Gonzaga said they would press the complaint because of the damage resulting from the oil spill. Guimaras Gov JC Rahman Nava said they are saddened with the dismissal of the complaint. "We will exhaust whatever legal measures that are available to us," he said. The governor refuted criticisms that the complaint that they filed was inherently Environmental groups said Petron Corp should be made to answer for the oil spill that has destroyed the livelihood of thousands of Guimaras residents and devastated the island's rich marine resources. The Save Our Lives, SOS!, composed of nongovernment organisations, scientists and environmentalists, said the cleanup and rehabilitation of the affected areas and residents were only a part of addressing the oil spill. Guimaras Provincial Prosecutor Luzermindo Calmorin issued a 17-page resolution on Mar 2 dismissing the criminal complaint filed against Petron officials and the owners of the sunken vessel for lack of probable cause. "In fine, while it appears that the oil spill has indeed caused damage to the affected

communities and fisherfolk in the municipality of Nueva Valencia, it does not follow that there is criminal liability involved," said Calmorin in his resolution. Calmorin dismissed the complaint filed on Sep 13 by Gonzaga in behalf of his constituents. The town is the hardest hit by the oil spill among the five municipalities of Guimaras. The respondents included Petron president Khalid Al-Faddagh and Nicasio Alcantara, chairman and chief executive officer, Felimon Antiporta, vice president for operations, and Carlos Tan, health safety and environment officer and company spokesperson. Also named was Clemente Cancio, president of the Sunshine Maritime Development Corp, owners of Solar 1. In his complaint, Gonzaga had accused the respondents of violating Republic Act 9275, the Clean Water Act of 2004,, Republic Act 8749, the Clean Air Act of 1999, and Republic Act 9003, the Ecological Solid Waste Management Act of 2000. He said the oil spill caused massive destruction, damaged the province's rich marine resources and severely affected their tourism industry and economy. He also said that fumes coming from the oil sludge caused ailments among the residents and polluted communities. Gonzaga also accused the respondents of being responsible for the unauthorised dumping of contaminated debris in San Antonio village and the alleged spraying of unauthorised chemicals along the shoreline of Barangay Guiwanon. However, in his resolution, Calmorin said the respondents could not be held liable of violating the Clean Air Act because the law applies to "intentional or deliberate acts." is nothing on record, not even an allegation by the complainant, that the respondents intentionally sank the vessel and spilled, leaked, dumped or discharged its bunker fuel cargo," said Calmorin in his resolution. He said the respondents could also not be made to pay fines and damages because "none of the acts, which would constitute a gross violation of the law, has been alleged or substantiated? prosecutor also cleared the respondents of any violations of the Solid Waste Management Act. He said the law was not applicable to bunker fuel cargo of the sunken tanker. "In fact, it was not intended to be discarded but was shipped precisely to be used as a fuel in Zamboanga. It cannot be therefore, considered as waste or discarded material." Calmorin also dismissed the complainant's allegation that Petron personnel dumped contaminated debris in San Antonio village and sprayed of chemicals in the shoreline without authorisation. He said the evidence showed that there was no intention to permanently dump debris in the village and it was only used as a transhipment point. The resolution said the complainant failed to establish that the materials sprayed by Petron-hired personnel were prohibited and unauthorised.

London, Mar 26 — A press report, dated today, states: The No 4 tank of

non specific tanker Solar 1 was found empty of oil when research Allied Shield completed the penetration on the starboard side of the vessel on Mar 19. However, tank No 3 on the port side of the vessel yielded oil. Office of Civil Defence (OCD) VI Director Rosario T. Cabrera said in a report that Allied Shield completed penetration into tank No 3 through hull safety valves and commenced the transfer of the oil into a shuttle tank. The OCD director's report did not elaborate on how much oil had been recovered. The recovered oil will be transferred to ISO tanks on Allied Shield today and once the tanks are full, the recovered oil will be transferred to a tanker. The entire process will be repeated until all the oil is recovered. Contingency measures are in place to deal with any sort of oil leakage during the recovery operations, Presidential adviser for Visayas Rafael Coscolluela said.

Manila, Mar 26 — The Philippine Department of Justice today charged the Japanese and Filipino owners of Sunshine Maritime Development Corporation, owners of the sunken non specific tanker Solar 1, with violation of the country's anti-dummy laws. State prosecutors found probable cause against Japanese nationals Hiroyasu Yamaguchi, chairman of the board and treasurer of Sunshine Maritime, Mototsugu Yamaguchi, board member and vice president, and board members Tomoki Tsubomoto and Hiromi Irishika. Also charged were their Filipino partners identified as Sunshine Maritime president Clemente Cancio, Dionisio Parulan, Roberto Mena, Gregorio Flores and Angelita Buenaventura. The company officials were charged before a Manila regional trial court. Under Philippine law, a domestic shipping company should be majority, or 60%, owned by Filipinos. In the case of Sunshine Maritime, Pesos 4 million (US\$83,333) of its P5.5 million paid-up capital was contributed by its Japanese partners. If convicted, the officers of Sunshine Maritime could face from five to 15 years imprisonment as well as hefty fines. The Japanese partners, however, are unlikely to serve possible sentences as they are all based Lloyd's Japan. List Correspondent.

Manila, Mar 26 — Research Allied Shield reported that it had penetrated the port side No 5 tank of non specific tanker Solar 1 over the weekend (Mar 24-25) and found still undisclosed quantities of bunker fuel inside the compartment. This is the third of Solar 1's 10 storage tanks that Allied Shield has penetrated. Oil recovery is continuing at the No 5 tank, which will be followed by the installation of hull safety valves at port side No 2 tank. — Lloyd's List Correspondent.

Manila, Mar 27 — After penetrating six of the ten oil storage compartments of sunken non specific tanker Solar 1 offshore support and recovery vessel Allied Shield reported that it had recovered only minimal amounts of bunker fuel. In its latest report released Tuesday (Mar 27), Allied Shield said that it had penetrated

portside tank no. 2 and starboard tank no. 2 but found these tanks empty of oil. Over the weekend the air hatch of starboard tank no. 5 was opened and also found to be empty. Earlier, starboard tank no. 4 was penetrated and was also found to be negative for oil. So far of the six oil compartments entered only two, portside tank no. 5 and portside tank no. 3 have yielded any oil. While no figures were given on the amount of oil recovered it is believed to be negligible. The low oil recovery has fueled speculation that most of Solar 1's cargo of 2.0 million litres of bunker fuel leaked out when it sank on Aug 11 last year. - Lloyd's List Correspondent.

London, Mar 26 — Following received from Coast Guard Cleveland, timed 1817, UTC: Bulk cement carrier Stephen B.Roman refloated by its own means and berthed at Rochester. The vessel is currently under way to

Oswego. London, Mar 29 - Bulk cement carrier Stephen B.Roman, which brings cement to Rochester, almost ran aground entering the port last week. The U.S. Coast Guard said that the vessel "bumped bottom", apparently hitting some shoals that had formed since the vessel last came to Rochester on Jan 11. The vessel was in the centre of the channel near the mouth of the river last Friday (Mar 23) when the crew had to take action to stop the her. Steve Hewitt, Essroc Rochester Spokesman said: "At that point in time there really wasn't a lot of choices other than to take Stephen B.Roman back to Oswego and finish off-loading cargo there." Essroc ships cement from Canada to riverfront facilities in both Oswego and Rochester twice a week. The vessel had already called at Oswego and had only a half load on board, when it entered Rochester and it still "got stuck". The ship has a draft of 19 feet. The last time the river was dredged was 2004. The U.S. Army Corps of Engineers in Buffalo says the dredging scheduled for this summer was cancelled because of budgetary constraints and the dredge is only removing about half of what it used to. "Now we're dredging out there every three years," said Michael Asquith, U.S. Army Corps of Engineers dredging programme manager. "And in fact, it was cancelled this year, so it will be every four years. And we're only

dredging now maybe about 120,000 or 130,000 cubic yards. So we've cut our quantity almost in half, and we're dredging less frequently." Essroc is now trucking cement in from its Oswego port facility and some customers will be served by trucks directly out of Oswego. Essroc says it doesn't know yet whether this will have an impact on the price of cement at the beginning of construction Congresswoman Louise M. Slaughter (D-Fairport), and Chairwoman of the House Rules Committee, said "The Port of Rochester is vital to commerce and recreation, and I want to assure the citizens of Rochester and other local communities that I am using every resource I have to resolve this situation. My staff and I have been in regular contact with the Essroc Cement Corporation, the Army Corps Headquarters, and the City of Rochester, and together, we are examining a variety of approaches to fixing this problem." Rochester is pretty low on the federal government's priority list of harbours to be dredged, as it only handles 141,000 tons of cargo a year. The Corps of Engineers says Essroc can pay for the dredging itself. The cost is estimated at about \$750,000, but there is no mechanism for the company to be repaid.

SUPERSEACAT TWO (U.K.)

London, Mar 25 — Passenger ro/ro Superseacat Two has resumed its service on the route between Liverpool and the Isle of Man after an engine overhaul. It has undergone maintenance work and is now operating its usual route between Douglas and Pier Head.

TAKU (U.S.A.)

London, Mar 24 - A small fire on Thursday (Mar 22) caused minor smoke and water damage to a stateroom on board the state passenger ro/ro Taku (2625 gt, built 1963), which is being refurbished in Washington state. There were no injuries in the fire, which was confined to an interior cabin deck, said Alaska Department of Transportation spokesman Mike Chambers. A cutting operation above the stateroom caused the fire in the empty stateroom, Chambers said. Sprinklers activated in the stateroom and extinguished the fire. "The fire was out before the fire department arrived," Chambers said. "It was primarily smoke and water damage." Taku is in the Todd Shipyard Taku is in the Todd Shipyard in Seattle as part of a federal refurbishment project, Chambers said.

Seattle, Mar 28 — Quick action by Todd Pacific Shipyard personnel and AMHS crew members, along with the implementation of the shipyard's fire prevention plan, prevented the fire in Cabin 27B on board passenger ro/ro Taku from spreading. Repairs will be carried out at the shipyard. — Lloyd's Agents.

TASMAN COMMANDER (Hong Kong)

Noumea, Mar 29 — At approximately 0730 hrs today, general cargo Tasman Commander (18468 gt, built 1995), with a pilot on board, hit Noumea quay when she was berthed. UNICORN ACE (Panama)

London, Mar 23 — A press report, dated today, states: The Philippine Coast Guard yesterday sent an environmental protection team to monitor a possible oil spill from general cargo Unicorn Ace that sank in northern Luzon last Wednesday, a senior official said. "There is a possibility that oil may have leaked from the vessel which sank off Ilocos Norte," said Coast Guard spokesman Lieutenant S.G. Armand Balilo. "We have to protect marine life and the environment in the affected areas, Balilo added. One crewman was killed and five others remained missing after the ship sank in the South China Sea off Ilocos Norte. The Coast Guard, Philippine Navy and Hong Kong Rescue Centre have Maritime search-and-rescue continued operations.

London, Mar 25 — Following received from Coast Guard Manila, timed 0040, UTC: After an aerial search, no sign of

the missing five crew of general cargo ${\it Unicorn\ Ace}$ was found.

London, Mar 26 — Following received from Hong Kong MRCC, timed 1631, UTC: Two crew members from general cargo *Unicorn Ace* who were rescued by general cargo *Sea Angel* have been landed at Hong Kong, along with the body of the dead crewman. Five crew are still missing

are still missing.

London, Mar 27 — A press report, dated today, states: The 11 Chinese crew members rescued from general cargo Unicorn Ace, which sank a week ago in the northern Philippines, returned to their hometowns from Manila today, a Chinese embassv official said. The 10 seafarers from the Chinese mainland, seven of them from Shandong province, left Manila for Hong Kong on board a flight from Ninov Aguino International Airport at 0620, local time, Huang Li, the Chinese consulate official who saw them off, said. Company representatives from Qingdao will receive the crew, who are in good condition, he added. One crew member from Taiwan also took a flight this morning for Taipei, according to Huang. (See issue of Mar 28.)

Manila, Mar 28 — The Philippine Coast Guard said that it had called off search and rescue operations Monday (Mar 27) for the three missing crew members of general cargo Unicorn Ace. The Coast Guard said that one of its helicopters has been searching the area where the vessel sank, for the past week, but there has been no sign of survivors. Unicorn Ace was on its way to Pasir Gudang, in Malaysia, from Shanghai, when it sank 80 nautical miles off Currimao Point, in the northern Philippine province of Ilocos Norte, on Mar 21. Of its 19 crew members, one was killed and 15 were rescued by passing vessels. — Lloyd's List Correspondent.

VARNEBANK (Netherlands)

Two tugs refloated the vessel, which was then towed to Cuxhaven with a list of 10 deg. It sustained two gashes in its ballast water tanks. The investigations in Cuxhaven are continuing.

London, Mar 26 — Information received from Kiel, dated today, states: General cargo *Volgo-Balt 209* has been towed by tugs of Otto Wulf from the Lentzkai, in Cuxhaven, to the New Fish Harbour, still with a strong list to starboard.

London, Mar 27 — Information received from Kiel, dated today, states: General cargo Volgo-Balt 209, on Scharhoern reef in the night of Mar 23, had the Weser pilot on board. The vessel carried a cargo of 2960 tons coal from Russia. The first vessel on scene

was the DGzRS-rescue boat Hermann Helms from Cuxhaven. At 2230 the multipurpose vessel Neuwerk and the police patrol Buergermeister Brauer arrived on scene. When the tugs Taucher Otto Wulf 3 from Cuxhaven and the ${\it Parat}$ from Brunsbuttel had reached the vessel, the tide was too low for refloating the vessel. At 0215 the vessel finally was refloated and towed to Cuxhaven with 9.5 deg list to port. Two of the three ballast water tanks had been breached when grounding. The vessel then was berthed in the Amerikahafen (America Harbour) in Cuxhaven, but as the the water was too low due its movements caused by strong winds, Wulf-tugs towed the vessel, at 1730, into the New Fish Harbour for investigations. The repair yard is unknown yet as the dock of the Muetzelfeldt-Yard is occupied by another vessel and no other dock in port large enough to take the vessel.

London, Mar 27 - Information received from Kiel, dated today, states: the Divers from company Kirchgaessner surveved the underwater region of general cargo Volgo-Balt 209 on Mar 24. They found out that the hull is damaged for a length of 30 metres. There were dents and breaches. Both propellers are seriously damaged and will have to be replaced. The shelter of the propeller on starboard side is missing, the one on port side is damaged. On starboard the vessel sustained damage above water due to wave impact during the six hours on the reef.

London, Mar 28 — Information received from Kiel, dated today, states: General cargo Volgo-Balt 209 ran aground because the Weser Pilot wanted to shorten the way to the Elbe via the old Weser thereby leaving the lane marked by buoys. The man has been warned by the river control that he will be prosecuted. Volgo-Balt 209 will possibly have to be scrapped as the amount of damage caused is higher than the vessel's value. It is still berthed in Cuxhaven after completition of the divers' investigations.

London, Mar 27 — A press report, dated today, states: The families of Kenyan seamen hijacked in Somalia a

month ago have pleaded with the Government to intervene to have them released, as reports indicate the pirates have reduced their ransom demand from US\$1 million (Sh69 million) to US\$170,000 (Sh11.7 million). The families said they had not received any word from their relatives and were concerned about their safety in the lawless country. "We understand that the country is back to the chaotic scenes and we are concerned about their safety," said Mrs Aisha Salim, mother to Salim Hanafi, a crew member on board general cargo Rozen. Rozen, a World Food Programme chartered vessel, was hijacked 750 nautical miles from Mogadiscio on Feb 25. Mr Andrew Mwangura, the Seafarers Assistance Programme coordinator, who met the families yesterday, said the pirates had reduced the ransom demand. He said the master of the vessel and a Kenyan crew member had been removed from Rozen to an undisclosed location for fear that it could be attacked by coalition forces patrolling the area. He also confirmed that two pirates were killed during an exchange of fire between the Puntland authorities and the hijackers. Mr Mwangura and the vessel's agents, Motaku Shipping Agents, said the crew was running out of food and water.

FINDINGS (Cayman Islands)

London, Mar 25 — A press report, dated Mar 22, states. The £4 million yacht *Findings* (290 gt, built 1991) has been impounded by police in Italy after an investigation was launched into the death of an East Lancashire man. Boat engineer Simon Johnson, 35, was found dead in mysterious circumstances on board the Jersey-registered yacht earlier this week. The former ski instructor had been working as an engineer on the yacht off the coast of Genoa. He was found dead in a cabin by a security guard but is believed to have died 18 hours earlier. A postmortem examination has been carried out in Italy, but the results were inconclusive. His family are anxiously waiting for tests to confirm the cause of death. His body is now back in the UK awaiting further tests and an inquest was opened into his death by Blackburn coroner Michael Singleton yesterday. The coroner's officer said: "It is too early to say whether Mr Johnson's death is suspicious or not but the Italian authorities have seized the yacht as part of their ongoing inquiries."

FISHING VESSELS SEIZED BY RUSSIA

London, Mar 29 - A press report, dated today, states: Four vessels have been detained over the past 24 hours off the Primorye Territory for illegal fishing and violation of the state border, reports said on Thursday (Mar 29) at the press group of the border branch of the Russian Federal Security Service for the Primorye Territory. According to air reconnaissance, four fishing boats without flags of state sovereignty, without names and identification signs were spotted in the central part of Peter the Great Bay, in Russian territorial waters. Coastguard vessels rushed to the area. Borderguards were forced to open fire in order to detain one of the vessels. There were no casualties. Three Russian vessels and a seiner, flying the Cambodia flag, turned out to be the transgressors. An inspection group found 11 tonnes of crabs on board the Cambodian Scat boat and 830 crab traps, some of which were ready for lowering. Another seven tonnes of illegally caught crabs were found on board Meridian (? fishing (general) Meridian (649 gt, built 1974)and fishing (general) Vynoslivyy (448 gt, built 1983), registered in the Primorye Territory. Borderguards detected only several crabs on board the third Russian vessel, the seiner Angor (366 gt, built 1995), of Sakhalin , on which the crew were short of time to throw them overboard. Not a single skipper could fetch any permissive documents for fishing. All the detained vessels were escorted to Nakhodka port. The facts of illegal fishing are being investigated. Crabs, to be recognized as

viable in the presence of an ichthyologist, will be released into sea on Thursday.

GRISHA PODOBEDOV (Russia)

Portsmouth, UK, Mar 26 - General cargo Grisha Podobedov (2949 gt, built 1976), registered in Kamchatka, has been detained at the Chinese port of Dalian over debts to a shiprepair company. Chinese officials have handed a detention warrant to the master of the Russian vessel, a crewmember told Interfax by phone on Monday (Mar 26). "If the ship owner fails to repay the debt to the shiprepair company before Apr 20, the motor vessel will be sold," he said. "The crew have not received their pay for seven months now and their future is not clear," the Russian sailor said. "Repairs were finished a long time ago, but the ship owner has yet to repay debts to the Chinese shiprepair company and to the crew," he said. The vessel is owned by Kamchatmorflot company. Kamchatmorflot's other motor vessel, Tikhon Syomushkin, found itself in a similar situation in Vietnam in February. The problem was settled through diplomatic channels. — Correspondent.

The Georgian Interior Ministry border police press service said the ship was released after paying a \$30,000 fine and has already left the port of Batumi. The ship was detained nine days ago for allegedly sailing near the coast of the unrecognised Georgian republic of Abkhazia, which has been declared a closed area.

SHUEN MAN (Taiwan)

London, Mar 25 - Fifteen crewmen from Taiwanese fishing (general) Shuen Man have been detained in Brisbane as authorities investigate whether they were operating illegally in Australian waters. The 35-metre vessel was escorted into the Port of Brisbane around midnight, after being detected off Lord Howe Island earlier this week. It is suspected of illegally fishing in Australian waters after being intercepted about 65 nautical miles inside the Australian Exclusion Zone. Immigration officers have detained the crew. Nine of those detained claim to be Indonesian, four from China and the other two from Taiwan. Quarantine officers inspected the boat for biosecurity risks on arrival, with the Australian Fisheries Management now Authority heading investigation.

DELTA STATE, NIGERIA

Development Company of Nigeria has resumed pumping of crude oil through its Nembe Creek Trunk Pipeline, where a spill led to a shut-in of 187,000 barrels a day, a spokesman said today. However, the Nigerian government has sued the oil company for alleged violation of nuclear safety and radiation law, according to media reports today. "We have resumed pumping, but I cannot say how much it is now," Bisi Ojediran said. "Normally, is now," Bisi Ojediran said. "Normally, production will ramp up," he said. Ojediran said Shell wouldn't comment on the government's suit, "since the case is already in court." government, according to the report, accused Shell and three other companies - C and E Global Limited, Western Atlas, and E D Wayles - of transporting radioactive materials from Port Harcourt to Warri, both in the Niger Delta, without proper authorisation.

VITEBSK REGION, BELARUS

London, Mar 27 — A press report, dated topday, states: Latvia's emergency services were on high alert yesterday, as an oil spill in Belarus flowed along the Daugava river towards the Latvian border. The spill, estimated at more than 100 tons of diesel, began on Friday evening (Mar 23) in the Vitebsk region of western Belarus, when a section of pipeline burst and began spilling diesel into the ground. Belarusian rescue services managed to contain much of the spill, but by mid-afternoon on Saturday (Mar 24) an unknown quantity had flowed into the Ulla river. Approximately 1.2 hectares of land were also contaminated. The Ulla is a Belarusian tributary of the Daugava, known as the Dvina in Russia. The Daugava is Latvia's largest river and flows through both Riga and Daugavpils. Initial attempts by Latvian rescue services to place preventive booms across the river were hampered by high water levels and rapid currents. Latvia's rivers are running high as a result of the spring thaw and rains.



LONG ISLAND SOUND, NEW YORK, UNITED STATES

London, Mar 26 — A press report, dated today, states: Fishers Island Ferry District has agreed to pay \$200,000 to settle civil claims for violating the Rivers and Harbours Act by discharging raw sewage into the Thames River and Long Island Sound, federal authorities said on Friday (Mar 23). "This case demonstrates this office's ongoing commitment to prosecuting serious environmental violations to the fullest extent of the law and we will seek both criminal and civil penalties when appropriate to do so," said US Attorney Kevin O'Connor.

Capt Peter Boynton, who commands the Coast Guard's Long Island Sound division, welcomed the settlement. "The United States Coast Guard takes the prevention of maritime pollution very seriously and is firmly committed to the protection and preservation of the marine environment in Long Island Sound," Boynton said. "We hope that this settlement will serve as a deterrent to others." The Fishers Island Ferry provides daily year-round ferry service from New London to Fisher's Island, NY. The Fishers Island Ferry owns and operates two ferries that were used in the illegal discharges, authorities said. From 2000 to 2004. the overboard discharge valves for the sewage holding tanks on the vessels were kept and maintained in the open position, authorities said. The practice allowed hundreds of thousands of gallons of raw sewage and untreated sludge to be discharged into the Thames River and Long Island Sound, authorities said. On Jul 13, 2004, the US Coast Guard performed an unannounced inspection on the vessels that revealed the overboard discharge valves were open. Mark Easter, operations manager for the ferry district, pleaded guilty in 2005 to two counts of violating the Rivers and Harbours Act. Easter was sentenced last year to 30 days in prison and a \$10,000 fine.

London, Mar 24 — A total of 69 people were killed and more than 77,000 left homeless after cyclone "Indlala" struck northern Madagascar last week, authorities said overnight in a sharp upward revision of the toll. The national emergencies agency, the BNGRC, said new figures showed that 33 people were killed in the town of Port-Berge, in addition to the 36 dead elsewhere counted up to yesterday. The BNGRC said 77,674 people were made homeless, up from 53,750. In addition, 17 bridges and 40 public buildings had been damaged, and 8000 hectares of ricefields destroyed.

BATU TARA VOLCANO, KOMBA ISLAND, INDONESIA

London, Mar 24 - A press report, dated yesterday, states: Thousands of people on an eastern Indonesian island have were warned to prepare to evacuate after a volcano started spewing rocks and lava, authorities said today. The 748-metre Batu Tara volcano, which began rumbling last week, has released hot lava and rocks over the last two days and shot clouds of hot air up to 2,000 metres into the sky, said Andreas Duli Manuk, chief of Lembata District. Andreas said about 6,800 residents in six villages on the northern coast of Lembata Island, the closest islet south of the volcano, were on alert for evacuation. Some residents had already fled their villages to safer areas. Fishermen have been warned to stay at least three kilometres from the volcanic island, he added.

JAPAN

London, Mar 25 — A 6.9-magnitude quake struck Japan's main island of Honshu this morning. Landslides were triggered, roads buckled and at least 25 houses collapsed completely when the quake struck at 0942 hrs, Kyodo news agency said. The tremor, which was felt in Tokyo, seriously damaged some 200 houses, it said. The quake's focus was at a depth of 11 km below the seabed off the Noto peninsula in Ishikawa prefecture, about 300 km west of Tokyo. A 52-vear-old woman died in Wajima, a resort and fishing town on the western side of the peninsula, after being trapped under a stone lantern that toppled in her garden, officials said. About 40 people were being treated for injuries, mostly minor, in hospital in Wajima, a town of around 34,000 people, media said. The Japan Meteorological Agency originally estimated the magnitude at 7.1 but later revised it to 6.9. It had earlier estimated the depth of the focus at 50 km. Some trains were halted, people were trapped in lifts and there were reports of power outages in some areas. Water was cut off to 4,500 homes, Kyodo said. Flights were suspended between Tokyo and local airports in Ishikawa but high-speed bullet trains resumed service after being halted for checks, Kyodo said. A tsunami warning for waves of up to 50 cm issued for Ishikawa prefecture was later lifted after small tsunamis hit some areas. Power companies said there were no reports of irregularities at nuclear plants in the area. Earlier, two strong struck earthquakes near the archipelago of Vanuatu in the South Pacific, Australia's geological agency reported, but there were no reports of damage.

London, Mar 25 — Following navigation warning received today,

states: Earthquake information: Earthquake occurred off Noto Hanto at 0042, UTC, today; magnitude 7.1; dangerous drifting objects, change of depth and damage of harbour facilities or navigational aids may occur. Vessels in coast area requested to be cautious.

Wajima, Mar 26 - Aftershocks jolted the west coast of central Japan today, after a strong earthquake killed one person, injured nearly 200 and flattened homes. Yesterday morning's 6.9 magnitude quake, which struck the Noto peninsula in Ishikawa prefecture, about 300 km west of Tokyo, destroyed houses, buckled roads, triggered landslides and cut off water and electricity supplies to thousands of homes. A 5.3 magnitude tremor, one of more than 175 aftershocks, struck early today, and a 4.8 magnitude quake jolted the area in mid-afternoon, Japan's Meteorological Agency said. Officials warned that more could occur. About 2,600 people spent the night in evacuation shelters and many other residents slept in their cars. Prime Minister Shinzo Abe told parliamentary panel in Tokyo that 68 houses, many of them old wooden structures with heavy tile roofs, had been destroyed and another 164 badly damaged. The government's disaster agency put the total number of damaged houses at 564 and public broadcaster NHK said more than 10,000 households lacked running water. An emergency relief team of firefighters that had been searching the rubble of collapsed houses confirmed that no-one was trapped, an Ishikawa prefecture official said. Electricity was restored to most homes after outages yesterday affected around 160,000 households, Noto airport on the peninsula re-opened after cracks on the runway were repaired, and train services were back to normal, officials and media said. — Reuters.



IRAN

London, Mar 24 — A group of British sailors were detained by Iranian forces overnight as the UN Security Council prepared to vote on extensions to its sanctions against the country. The 15 sailors were conducting anti-smuggling checks in a disputed stretch of water between Iraq and Iran, the Shatt al-Arab waterway, in line with a UN Security Council resolution. The British Ministry of Defence has demanded their immediate release. A senior Navy commander said he hoped the capture - involving sailors from HMS Cornwall - was a "simple misunderstanding at a tactical level". A BBC television correspondent on board HMS Cornwall said the group had been seized at gunpoint. "The British seized at gunpoint. Government is demanding the immediate and safe return of our people and equipment," said the Ministry of Defence. "We are urgently pursuing this matter with the Iranian authorities at the highest level, and on the instructions of the Foreign Secretary the Iranian ambassador has been summoned to the Foreign Office." British media speculated the sailors could be held hostage and used as a bargaining tool ahead of the UN vote on sanctions against Iran. The UN Security Council is expected to adopt a resolution this weekend broadening its sanctions against Iran over the country's refusal to halt nuclear fuel work.

NIGERIA

London, Mar 23 — A press report, dated today, states: Gunmen in speed boats kidnapped a Dutch security manager of a German construction company in Nigeria's oil capital, Port Harcourt, today, security sources said. The attackers invaded the construction yard of Bilfinger Berger on the waterfront at dawn, engaged guards in a three-hour shoot-out and abducted the security manager when he went to investigate what was happening. The company has tried unsuccessfully to contact the group that kidnapped him, he added.

PAKISTAN

London, Mar 24 — A press report, dated today, states: Gas supply was suspended to the purification plant from a well of the Sui gas field as militants blew up a pipeline yesterday. Official sources confirming the incident said that tribal militants placed a locally-made powerful bomb under the pipeline supplying gas to the main plant from well No 86 and blew it up. Security forces and PPL officials rushed to the site and immediately cut off the gas supply. "An eight-inch diameter of the pipeline was blown up in the blast," police sources in Sui said.

Karachi, Mar 26 - The crude oil pipeline owned by Pakistan and Abu Dhabi joint venture-Pak Arab Refinery Ltd (Parco) was blown up near Rojhan in Rajanpur district, some 200 km from Dera Ghazi Khan, in Punjab Province of Pakistan early yesterday morning. According to media, the 16-inch diameter pipeline supplying oil from Karachi port to the Mahmoodkot refinery in Muzaffargarh district was blown up in the limits of the Mazaridominated area of Chouki Kin, Rojhan tehsil, at 0300 hrs, damaging a threemetre portion of the pipeline. A Parco official said that the pipeline was nonfunctional due to the annual repair work from Mar 12 and the remaining oil in it went to waste after the blast. The engineering team has reached the blast site to repair it. - Lloyd's List Correspondent.

SRI LANKA

Lonon, Mar 26 — A press report, dated today, states: Tamil rebels, for the first time, used light aircraft to attack a Sri Lankan Air Force base adjoining Colombo's international air port, military officials said today. The

rebel assault killed at least two airmen and wounded 17 others, as the airport suspended operations temporarily, Air Force spokesman Group Captain Ajantha Silva said that rebels are believed to have used two light aircraft to drop explosives in the early hours of today, onto the base at Katunayaka, 23 kilometres north of the capital. Bandaranaike International Airport has been temporarily closed, and all flights scheduled to land in Colombo have been redirected to other airports in India and Thailand, said SriLanka airlines communications manager Chandana Silva. At least seven flights with points of origin including Paris, Dubai, Frankfurt and London have been redirected to nearby countries. The flight from Frankfurt was directed to Kochin in India. Additional troops have been moved into the area to carry out a search operation, while all passengers heading to the airport from Colombo have been turned back. Tamil rebels claimed responsibility for the attack. Military spokesman Rasaiah Illanthirivan of the Liberation Tigers of Tamil Eelam (LTTE) confirmed the attack, saying that the two aircraft took off from the rebel-controlled Wanni northern region and returned to the base after the attack. He said the targets for the airstrike were hangers where Air Force Kfir and MiG-27 fastattack aircraft were parked. He threatened that other Sri Lanka military installations will be targets for future attacks. Residents in the area of the airport said that four loud explosions followed by gunfire were reported from the Air Force base, which lies 1,000 metres from the airport. The damage caused within the base by the airstrike was immediately not known. All Kfir fighter jets used to bomb suspected Tamil rebel targets operate from Katunayaka airbase.

Hong Kong, Mar 26 — Cathay Pacific Airways Ltd. has suspended flights to and from the Sri Lankan capital after a rebel aircraft bombed an air force base next to the Colombo international airport early today. Asia's third-largest carrier said in a statement it would resume its daily flights of Boeing 777-300 aircraft only after conducting a careful assessment of the situation. "We will just have to monitor the situation very closely," a company spokeswoman said. Three airmen were killed and 16 wounded in the pre-dawn attack by a Tamil Tiger light aircraft that dropped bombs on an air force base by the civilian airport that is 23 miles north of the capital. It was the first such air strike by the rebel group. Airline and government officials said the civilian airport was not damaged, but was closed for several hours after the attack. The Liberation Tigers of Tamil Eelam vowed to carry out more air attacks. - Reuters.

London, Mar 29 — Sri Lankan navy troops have sunk three Tamil Tiger boats off the island's north-east coast, killing at least 15 rebels, the military says. Officials said the navy fought a three-hour battle with 10 rebel boats. They said one navy sailor was wounded in the clash, which took place about 60

nautical miles from Trincomalee. The incident came a day after Sri Lankan troops said they had driven Tamil Tiger rebels from a major base in the east of the island. "A naval patrol has come across about 10 Tiger boats and our boats launched an attack, and we were able to destroy three rebel craft," quoted Reuters news agency Commander Athula Senaratne, a navy spokesman, as saying. "During the attack we believe 15 to 18 rebel cadres were killed." The remaining rebel boats fled, he said. There was no immediate comment from the rebels, who have been fighting for decades for a homeland for minority Tamils in the north and east of Sri Lanka. Despite a ceasefire still being in place on paper, Sri Lanka has been sliding back towards civil war, with more than 4,000 people killed in the past 15 months. On Tuesday (Mar 27), a Tamil Tiger suicide bomber killed himself and at least seven others in an attack on an army camp in the east of the country, the military said. The attack followed the rebels' first aerial attack, on a military base, on Monday. At least one light plane bombed an air force facility next to the international airport near the capital, Colombo.



AIR SENEGAL INTERNATIONAL PERSONNEL

Dakar, Mar 26 — Workers at Air Senegal International launched a twoday strike today, grounding flights to France and destinations across West Africa. Staff at Air Senegal, with services from Dakar to around 10 neighbouring countries as well as France, Italy and Spain, called the stoppage to demand an increase in their wages, their unions said. "There will be no flights today or tomorrow," Moustapha Diakhate, co-ordinator of the unions representing Air Senegal's employees, told Reuters. spokesperson for the company, which employs around 500 people, said negotiations had begun but declined to comment further. — Reuters.

FRANCE

London, Mar 23 — Workers operating the the Lavera and Fos oil terminals have still not accepted the "protocol of agreement". Therefore the strike continues at the oil terminals, although work has resumed at the dry bulk cargo/container terminals and private jetties.

London, Mar 23 — A press report, dated today, states: Bunkering operations are still being blocked by a strike at the Marseilles-Fos-Lavera port complex. One of the major bunker suppliers in the hub said today that her company had made no deliveries for over a week. She said strikers were planning a meeting before the weekend, but she was not optimistic

that bunkering would be able to resume soon. Strikers have been preventing vessels accessing the terminals, making it impossible for bunker barges to load. The Port Authority said the 10-day old dispute had halted all oil traffic. More than 30 vessels, including 23 oil tankers, were waiting outside Fos and Lavera terminals earlier this week.

London, Mar 26 - A press report, dated today, states: Marseille port authorities and representatives from French union Confederation Generale du Travail are meeting today in an attempt to end a strike which has entered its thirteenth day, a spokeswoman for the port said. Unloading at the oil and gas terminals at the ports of Fos and Lavera have been blocked since Mar 14, as workers protest against Gaz de France's decision to use only specially trained workers on its future Fos liquified natural gas terminal and not Marseille workers. According to the port authorities 47 vessels, including six gas tankers and 23 oil tankers, were waiting to unload Saturday (Mar 24).

London. Mar 27 Union representatives and the Marseille port authority were once again locked in talks, yesterday, aimed at trying to resolve a dispute that has paralysed oil terminal activities at Fos and Lavera since Mar 14. As of yesterday morning there were 49 ships, including 26 tankers, 17 chemical carriers and six gas carriers, queuing up outside the two terminals. Although the port said on Friday that union leaders had recommended, during a meeting, that members should return to work, they had decided to continue the strike.

London, Mar 28 — Strikers at the port of Marseille have voted to continue their industrial action, which has paralysed the oil terminals at Fos and Lavera, for a further 24 hours. Workers took the decision to continue the strike, now in its fifteenth day, at a meeting held yesterday afternoon. As of yesterday morning 51 vessels, including 28 tankers, 17 chemical carriers and six gas carriers, are awaiting entry to the two terminals.

London, Mar 29 — A press report, dated today, states: A meeting involving French regional governmental authorities, Confederation Generale du Travail labour union, Gaz de France representatives and the Marseille Port authority began at 0850 UTC, today, in an attempt to put an end to the 16-day port workers' strike, a spokeswoman for the prefecture said. At 0800 UTC, today, 57 vessels including 33 oil tankers, 18 chemical tankers and six gas tankers were waiting outside the port, a Marseille Port Authority spokeswoman said. This is the third meeting between unions, GdF and local authorities and comes after the CGT workers voted Tuesday (Mar 27) for the strike to continue, rejecting another plan to end the blockade. The workers on strike, unlike dockers, are employed by the Port Autonome de Marseille and therefore by the French

state. The strike has cost refiners about EUR25 million so far and is threatening fuel supplies, the French oil trade organization said yesterday. "Refineries will start stopping one-byone as soon as Friday, which will inevitably lead to a shortage" of refined products, l'Union Francaise des Industries Petrolieres said in a statement.

NETHERLANDS

London, Mar 29 — Towage services provided by SMIT Harbour Towage, Rotterdam, were suspended from 1205, yesterday. At this point, it is not known how long the suspension will last.

VASILEOSTROVSKIY (Russia)

Portsmouth, UK, Mar 22 - The crews of fish factorys Vasileostrovskiy (2416 gt, built 1989) and *Kronshtadtskiy* (2416 gt, built 1990) recently arrived at St.Petersburg from Murmansk have declared a strike. The wages of the crews have not been paid for several months. On Mar 22 the crews declared their intention to strike in order to protect their rights. The management of the company/shipowner "Transmar" refused to comment. — Correspondent. (Note — Vasileostrovskiy arrived St. Petersburg Mar 10 and according to Lloyd's MIU AIS both vessels were reported 0.7 nautical miles from Kanonerskiy Is, Russia, at 1455, UTC, today.)

St. Petersburg, Mar 27 — The crews of fish factory *Vasileostrovskiy* and fish factory *Kronshtadtskiy* laid a class action to Procuracy with regards to non-payment of wages within the period of four to five months. At the moment ship owner, Transmar, is trying to patch up the dispute. — Lloyd's Agents.



WAREHOUSE, HUMBOLDT, TENNESSEE, UNITED STATES

London, Mar 29 - A press report, dated Mar 28, states: Fire broke out in a chemical storage facility today, forcing as many as 700 people to evacuate homes and businesses in the area, officials said. Homes downwind were evacuated because of the smoke and workers at nearby manufacturing plants were told to leave as a precaution, Mayor Allen Barker said. No injuries were immediately reported. Firefighters were still working this evening, a dispatcher said. Some evacuated residents were allowed to return. The fire was at the Helena Chemical Co. warehouse and office in Humboldt, Helena Chemical makes crop protection products, agricultural chemicals, seed, fertiliser and related products. Officials with the Colliervillebased company issued a statement

saying they believe the fire was started by lightning. Firefighters could not use water because of the chemicals in the building, so they had to wait for it to burn down before applying foam, Barker said. Company officials said the facility includes an office for salespeople, as well as the warehouse holding products for sale to farms. However, the fire started before business hours and no-one was in the building at the time, they said. Fire Department dispatcher Derrick Seymour said that the fire was reported around 0600 hrs and that firefighters found the building engulfed in flames.



ABORTED TAKE-OFF, BEN GURION AIRPORT, ISRAEL

London, Mar 25 — An El Al flight to Zurich, carrying 128 passengers and six crew members, was forced to stop during its take-off from Ben Gurion Airport when the cockpit was filled with smoke. The passengers were evacuated from the aircraft and no one was injured.

ACCIDENT, SOUTHEND AIRPORT, ESSEX, UNITED KINGDOM

London, Mar 25 - A pilot has been praised by fire crews after safely landing his aircraft after its landing gear collapsed with seven people on board. Firefighters were called to Southend Airport, Essex, after a distress call from a pilot who said he had problems deploying his landing gear. When the aircraft landed the front landing gear collapsed and it skidded down the runway on its nose. Firefighters were called but no-one was injured in the landing yesterday. Assistant Divisional Officer Martyn Hodder said: "The pilot did an incredible job, as the plane hit the runway the front landing gear collapsed and the plane skidded down the runway on its nose." There were a total of seven people on board including a man, a woman, three children, a pilot and a co-pilot. None of the people on board were hurt in the incident.

AIRCRAFT PUT BACK TO ORLANDO INTERNATIONAL AIRPORT, FLORIDA, UNITED STATES

London, Mar 29 — A press report, dated Mar 28, states: An aircraft that had taken off from Orlando International Airport quickly returned for a landing after a possible mechanical problem, said airport spokeswoman Carolyn Fennell. The aircraft, which was operated by Continental Airlines, had 139 passengers on board when it started reporting problems after 2200. The Pilots were worried it may have had a leak in its hydraulic system. There

were no injuries. The airline was making other arrangements for passengers, Fennell said.

CRASH, AUSTIN, INDIANA, UNITED STATES

London, Mar 26 — A press report, dated Mar 25, states: A plane crashed in the back yard of an Austin, Indiana, resident just after 1700 hrs, today. The two people onboard the plane, a married couple: Dan and Barbara Burns, were airlifted to University Hospital in Louisville. They were listed in stable condition at University Hospital late tonight. Officials said that the Cessna $15\overline{0}$ plane they were flying in clipped the treetops and crashed into a house at 4878 N. Meridian Avenue, shortly after it took off from a nearby airport. Witnesses said that the plane burst into flames not long after it hit the ground, just before the pair was pulled to safety. Local resident Amy Coomer said "there was a lot of debris" after the crash, and a big rut where maybe the plane had hit the ground." The exact cause of the crash is still under investigation, According to Scott County police, the plane possibly lost power, and that may have led to the crash. The FAA was expected to join the investigation tomorrow.

London, Mar 28 — Cessna 150M N66673 crashed at Austin, Indiana, at 1724, Mar 25. The two persons on board were injured.

CRASH, CULLUNAN, SOUTH AFRICA

London, Mar 24 — Two men were seriously injured after a private aircraft they were travelling in crashed at the Cullinan diamond mine this morning, Pretoria police said. Inspector Paul Ramoloko said the men in their late 40's were trying to view the mine from above. They were apparently trying to land and flying low over the area when the aircraft crashed. The men were rescued by Cullinan Emergency Services and taken to a nearby hospital.

CRASH, GAINESVILLE, GEORGIA, UNITED STATES

London, Mar 26 — A press report, dated Mar 25, states: A small plane flown by a student pilot crashed just after noon today, at Lee Gilmer Memorial Airport, after its landing gear failed to open. According to Gainesville Police, the plane, owned by Aviation Atlanta, was damaged when the plane touched down, but no-one was injured. The Federal Aviation Administration and the National Transportation Safety Board are investigating.

CRASH, GREENACES, FLORIDA, UNITED STATES

London, Mar 23 — A press report, dated Mar 22, states: A former Boca Raton resident says she has won a seven-figure settlement in a lawsuit stemming from a 2003 plane crash in Greenacres, that killed her husband, the pilot. A National Transportation Safety Board report ruled that Norman

Lowenstein's fatal crash was caused by pilot error, probably brought on by an excessive amount of an over-thecounter antihistamine. His widow, Roberta, said: "He was a phenomenal pilot and I knew the reporting was inaccurate. It wasn't pilot error or drugs so I hired [attorney] Ed Curtis and independent inspectors to go to the site." They found that the 10-seat Cessna 441's right propeller was in a reverse-thrust position, signifying a mechanical problem with the aircraft, according to Curtis. A toxicologist hired by Mrs Lowenstein determined that the elevated antihistamine level was probably a result of changes to the body after death. "By the time we started talking about settlement, I don't think anybody ever believed drugs had any impact on the crash," Curtis said. "If you went back and looked at the NTSB reports where the pilot was taking some sort of antihistamine, a very large percentage were found to have high post mortem amounts. A [Federal Aviation Administration] bulletin came out doubting the accuracy of that finding. "The NTSB stands behind its findings," agency spokesman Ted Lopatkiewicz said. In a written statement, Lopatkiewicz said the NTSB is aware of the phenomenon of postmortem redistribution of antihistamine and any other drug. "We know how to look for it, when to suspect it and how to account for it," he wrote. "Unlike alcohol, antihistamine is not produced by the body after death; it must have been ingested before death." In December 2005, Lowenstein brought the suit in federal court. She said she recently struck a seven-figure settlement with defendants Cessna, Honeywell, which makes the Cessna's engines and some other parts and maintenance company West Star Aviation. Settlement terms are confidential. A spokesman for Wichita, Kan based Cessna said the company paid less than \$100,000 in a settlement of convenience." Phoenixbased Honeywell Aerospace "settled for a very small fraction of the total judgment cost," according to company spokesman Bill Reavis. West Star officials declined to comment. The \$1.5 million Cessna was being flown by flown by Norman Lowenstein on Dec 20, 2003, but when near the River Bridge community off Forest Hill Boulevard in Greenacres, the aircraft went into a flat spin and plummeted into a community pond.

CRASH, HILLENDALE GOLF CLUB AREA, BALTIMORE COUNTY, UNITED STATES

London, Mar 25 — A press report, dated Mar 24, states: Police in Maryland said three men were killed when a single-engine aircraft crashed this morning in Baltimore County. The men were identified as Theodore Ryder, Paul Sorensen and Timothy Connor. All three were from Joppa. Police said Ryder was the pilot. A National Transportation Safety Board spokesman said the Piper Saratoga PA-32 took off from Harford County Airport, in Churchville, and was on its

way to Abingdon, Virginia. The aircraft crashed shortly after take off, between 0900 hrs and 0930 hrs. Investigators from the NTSB, the Federal Aviation Administration, Piper and Lycoming, the maker of the aircraft's engine, are on the scene near Green Tree Drive and Country Club Lane. Fire spokeswoman Elise Armacost said the aircraft crashed near the Hillendale Country Club golf course, but it is not clear if the pilot was trying to land at the course. She said the aircraft crashed about 75 feet from a home, which was not occupied at the time.

London, Mar 26 - A press report, dated today, states: An investigator for the National Transportation Safety Board has ruled out an "in-flight breakup" or fire as the cause of the Baltimore County plane crash that killed three Harford County men on Saturday morning (Mar 24), an official said yesterday. The three men were on board a Piper PA-32-301 (Saratoga) that took off from Harford County Airport in Churchville at 0906 on Saturday. They were headed to Abingdon, VA, to attend a car race in Bristol, TN. Nine minutes into the flight, the aircraft crashed in the back yard of a home in the first block of Country Club Drive in Jacksonville. No one was in the house at the time of the crash, and there were no injuries on the ground. "The entire aircraft is right there at the accident site, so what that tells the investigator is there's no evidence of an in-flight break-up," said Ted Lopatkiewicz, a spokesman for the NTSB. "Also, there's no evidence of an in-flight fire." Todd Gunther, the air safety investigator assigned to investigate the accident, interviewed witnesses yesterday and will examine the engine, which was separated from the wreckage, in the next few days, Lopatkiewicz said. A preliminary report will be released in five to 10 days. Gunther has not yet determined how fast the aircraft was travelling at the time of impact, which could indicate whether the pilot was attempting to land. A more detailed report will be released in about eight months, but a final report, which will detail the cause of the crash, could take a year, Lopatkiewicz said.

London, Mar 27 — Piper PA-32R-301 (Saratoga IIHP) N324ST crashed near Cockeysville, Maryland, at 1319, Mar 24, while on a flight from Churchville, MD, to Abingdon, Virginia. The three persons on board were killed.

CRASH, HOWELL TOWNSHIP, NEW JERSEY, UNITED STATES

London, Mar 29 — A press report, dated Mar 28, states: A small aircraft crashed and burned in a wooded area of Howell Township, near the Jersey shore tonight, killing the pilot, authorities said. Howell Township Mayor Joseph DiBella said no-one else was on board. The pilot's identity was not immediately released. Witnesses said the aircraft went down at around 2000 hrs, in a park in the township's Ramtown section, about 100 yards from the nearest homes. No-one on the ground was hurt. A Federal Aviation

Administration spokeswoman said the aircraft was a Piper PA-28, a single-engine aircraft. The FAA and National Transportation Safety Board are investigating the cause of the crash.

CRASH, LEWES AREA, DELAWARE, UNITED STATES

London, Mar 27 — Bell 206B JetRanger N828BA crashed near Lewes, Delaware, at 2000, Mar 23, while on a flight from Lewes to Manassas, Virginia. The aircraft sustained substantial damage. The four persons on board were not injured.

CRASH, MALTA AREA, ILLINOIS, UNITED STATES

London, Mar 27 — A press report, dated today, states: A passenger in a private helicopter suffered minor injuries after the aircraft sustained damage in a field near Malta, Illinois, according to a statement from the DeKalb County Sheriff's Department. The pilot, who was not injured in the crash, told deputies that he landed the helicopter to check the cause of a warning light. When he attempted to take off again, one of the skids got stuck in the mud, causing the helicopter to roll onto its side, according to the statement. The rotor went into the ground, causing damage to the entire aircraft. The helicopter's passenger was taken to Kishwaukee Hospital with minor injuries. The pilot was treated and released at the scene. The Sheriff's Department is calling the crash an accident, but has turned the case over to the Federal Aviation Administration for further investigation.

London, Mar 28 — Rotorway 162F N162MC crashed near Malta, Illinois, at 2148, Mar 26. The two persons on board were not injured.

CRASH, MOGADISHU, SOMALIA

London, Mar 24 — The 11-person crew of a cargo aircraft that was shot down by a missile during take-off, died, officials said today. The downing of the aircraft, which yesterday delivered equipment for Ugandan peacekeepers in Mogadishu, came at the end of a particularly violent week in the Somali capital. Dozens of people, most of them civilians, were killed in fighting. Ten of the crew died in yesterday's crash. Rescuers found a wounded crew member and took him to a Mogadishu hospital where he died while being treated, said Hussein Mohamed Mohamud, spokesman for Somalia's president. All crew members were either Ukrainian or Belarussian, Mohamud said today, adding that their bodies will be flown back to their countries later in the day. Egi Azarian, acting head of Belarus-based Transaviaexport, confirmed that the company's plane was shot down but would not give any details. Mogadishu International Airport Manager Mohmed Ahmed Siyaad said that before the plane crashed, the captain contacted the control tower and said one of the engines caught fire. Transaviaexport, based in Minsk, Belarus, operates only Ilyushin-76s.

Mogadishu, Mar 24 — Belarus said today a missile caused an aircraft crash in Mogadishu that killed 11 of its citizens, while the Somali government said the crash looked more like an accident than an attack by insurgents. "The aircraft was shot down,' Transport Ministry spokeswoman Kseniya Perestoronina said in Minsk, adding that the large Ilyushin plane, in Somalia to assist struggling African peacekeepers, was hit at a height of 150 metres. Both a local Somali radio and an Islamist Website said a missile hit the Russian-made Ilyushin - used by a Belarussian firm - just after take-off from Mogadishu yesterday afternoon. However, witnesses who saw the aircraft burning in the sky and then crashing could not confirm it had been shot first. Somali Interior Minister Mohamed Mahamud Guled insisted the incident had the hallmarks of a technical fault, though investigations were under way to confirm exactly what happened. "As soon as the aircraft reached an altitude of 10,000 ft, the pilot reported an engine problem in engine No 2 and said he would turn back to the airport," he said in Mogadishu. Only one of the 11 persons on board - seven crew members and four engineers — initially survived the crash. The survivor was found wandering among corpses and wreckage but then died in hospital. -Reuters.

CRASH, MONTEGO BAY FREEPORT AREA, JAMAICA

London, Mar 29 - A press report, dated today, states: An AirPak Express cargo aircraft crashed in the Montego Freeport area yesterday after it reportedly developed mechanical difficulties, the police say. Corporal Constabulary Salkey, Peter Communication Network liaison officer for St. James, stated that the twopassenger Cessna aircraft, registered 6YJHO, went down about 1705, next door to The Lagoons and Sunset Beach Resort and Spa. Its occupants, the pilot and a female passenger, said to be of Chinese descent, were airlifted to hospital by a Jamaica Defence Force helicopter. The nose of the aircraft, which left Negril at 1645 destined for the Sangster International Airport in Montego Bay, was damaged. The first person at the scene was taxi operator Lloyd 'Big Dread' Wilson, who said he realised that something was wrong when he "heard a sound in the air' According to him, the aircraft was sputtering and circled the area before the pilot crash-landed in the open lot.AirPak Express staff, who were quick on the scene, reportedly removed the cargo that was inside the aircraft.

CRASH, MYRTLE BEACH, SOUTH CAROLINA, UNITED STATES

London, Mar 25 — A banner aircraft crashed about 100 to 200 feet offshore near Surfside Beach just before 1230, yesterday, according to an Horry County emergency official. The pilot, who was the only occupant, was able to get out of the aircraft and swim to the

beach, said Todd Cartner with Horry County Fire Rescue. He was taken to Conway Medical Centre where he was in stable condition with minor injuries. The Piper PA-18 floated in the ocean near Ocean Lakes Campground at 1330 hrs while the officials with the Federal Aviation Administration and the National Transportation Safety Board were notified of the crash. Cartner said. The aircraft was eventually pulled ashore and investigators worked yesterday to determine what caused the crash. No other injuries were reported during the incident, Cartner said. The aircraft was owned by Sky Signs LLC of Conway, said Kathleen Bergen, spokeswoman for the FAA in Atlanta.

London, Mar 27 — Piper PA-18-150 (Super Cub) N4330Z crashed into the water off Surfside Beach, South Carolina, at 1640, Mar 24, following take-off from Sky Field, SC. The one person on board suffered minor injuries.

CRASH, PONTE VEDRA BEACH, NORTH FLORIDA, UNITED STATES

London, Mar 27 — A press report, dated today, states: Two people were killed today when a small helicopter crashed and caught fire on the beach in Ponte Vedra Beach, North Florida. Officials were still trying to determine who was on board and said the National Transportation Safety Board will be investigating the crash. Witnesses heard the aircraft engine splutter before it nosed into the beach in St. Johns County. Investigators said they believe it is a training helicopter with Silver State Helicopters, which operates a training academy out of Craig Field. Investigators would not say whether the crash happened during a training flight.

CRASH, SPICEWOOD, TEXAS, UNITED STATES

London, Mar 26 - A press report, dated Mar 25, states: A private plane crashed this morning in Burnet County, according to the Texas Department of Public Safety. No-one was hurt. There were two occupants in the plane. Charles Connally of Spicewood owned the plane and was at the controls, when it went down near the Windemere private landing strip in Spicewood. The passenger was named John Dial - also of Spicewood. The aircraft was reportedly taking off when it lost power and crashed in the trees. The Federal Aviation Administration and the National Transportation Safety Board have been notified.

London, Mar 27 — PZL 101A N69NV crashed near Spicewood, Texas, at 1558, Mar 25, following take-off from Spicewood. The aircraft was destroyed. The two persons on board were not injured.

CRASH, YOGYAKARTA AIRPORT, INDONESIA

London, Mar 23 — A press report, dated today, states: Indonesia is giving six commercial airlines three months to improve safety standards or face closure, the country's aviation chief

said today. The audit was ordered by the government to evaluate transport safety following a string of deadly air accidents in recent months. First an Adam Air aircraft (Boeing 737-33A PK-KKV), carrying 102 people, disappeared in January, and on Mar 7 a Garuda aircraft (Boeing 737-497 PK-GZC) overshot the runway and burst into flames, killing 21 people. An audit of 54 aviation firms revealed that none of them made it to the first of three rating classes, said Budhi Muliawan Suyitno, the director general of civil aviation at the transport ministry. Fifteen companies, including six scheduled passenger airlines, were placed in the lowest category and were considered to have met only minimal standards of safety. National carrier Garuda Indonesia made the second grade. Suyitno said airlines in the third category would be given warnings to improve standards in three months. "If there's no improvement within three months, there will be a suspension order, and if there's still no improvement they will be shut down," he said. The airlines given three months to shape up were AdamAir, Kartika Airlines, Jatayu, Batavia, Trans Wisata Air and Dirgantara.

EMERGENCY LANDING. BELGRADE, SERBIA

London, Mar 26 - A press report, dated Mar 25, states: An aeroplane belonging to the German carrier Lufthansa had to make an emergency landing in the Serbian capital Belgrade this evening, after smoke built up in the cockpit. None of the 213 passengers or 11 crew members was injured in the incident, Serbia's RTS television reported. After damage to an electronic device was repaired, the plane continued on its flight from Frankfurt to Cairo, the report said.

EMERGENCY LANDING, DENVER INTERNATIONAL AIRPORT, **UNITED STATES**

London, Mar 23 — A press report, dated Mar 22, states: A Great Lakes Aviation flight with 30 people on board made an emergency landing at Denver International Airport afternoon. The Brasilia commuter aircraft had a blown tyre, according to reports. Airport spokesman Steve Snyder confirmed the aircraft had landing gear problems but said he did not have the details. The flight was from Gillette, Wyo., to Denver, and had 27 passengers and three crew members on board.

EMERGENCY LANDING, MANCHESTER AIRPORT. **UNITED KINGDOM**

London, Mar 28 — A press report, dated today, states: An aircraft carrying 50 passengers was forced to make an emergency landing at Manchester Airport as the pilot thought the aircraft's landing gear had broken. Crew on board the Flybe aircraft were unsure whether the

landing gear had been deployed or not. A faulty indicator light is believed to have caused the confusion. Flybe said there had been a "minor technical fault" but the aircraft had landed safely and passengers disembarked without incident. The crew contacted the control tower requesting a flypast to inspect the wheels. Observers on the ground confirmed the wheels had been deployed and the aircraft was allowed to land at about 0840, UTC.

EMERGENCY LANDING. ROME, ITALY

London, Mar 23 - A press report, dated Mar 22, states: A lightning strike forced the pilot of an Airmalta aircraft to make an emergency landing yesterday. None of the passengers and crew on the Malta to Rome flight were injured but many said it was a terrifying experience. The flight from Fiumicino to Malta scheduled at 1800 hrs, was then grounded yesterday for a couple of hours after the aircraft was hit by lightning during heavy storms on its approach to Rome. An official spokesman for the airline said that the aircraft was struck by lightning during its descent and the crew had taken all the necessary precautions for the safety of its passengers and crew. During such circumstances, top priority is given to safety, the spokesman explained. It was a normal flight until the descent and all of a sudden a bolt of lightning hit the wing. The pilot told passengers that the plane had been hit by lightning but there was nothing to worry about, a witness said. It is believed that the lightning caused a short circuit in the cockpit, but the pilot was able to control the steering of the aircraft when it landed.

EMERGENCY LANDING, SAKHALIN, RUSSIA

London, Mar 27 — A press report, dated today, states: An An-12 aircraft from Seoul has made an emergency landing on Sakhalin Island. During the flight the aircraft reported failure to lower nose landing-gear leg, an announcement made by the Far Eastern regional centre of the Russian Ministry for Emergencies said. The aircraft circled overhead above the destination airport of Yuzhno-Sakhalinsk, where rescuers were summoned, until full fuel runout. Prior to the very moment of landing, the crew managed to extend the nose landing-gear leg, and the aircraft landed safely at 2345, local time, on Monday (Mar 26). None of eight crewmembers was hurt. There were no passengers on board.

HELICOPTER CRASH,

URAL MOUNTAINS, RUSSIA
London, Mar 24 — A press report, dated Mar 23, states: At least two people died in the crash of a helicopter in the Ural Mountains in Russia. Two bodies were found at the site of the crash, the Novosti news agency reported. A spokesman for the prosecutor in the Komi republic said that snow is making rescue operations difficult. The Mi-8 helicopter, owned by

Gazpromovia, was on an environmental survey, flying over a national park, when it disappeared Wednesday (Mar 21). It was carrying a crew of five and one passenger. The helicopter crashed into a mountain at a height of 700-900 metres, an official in the emergency ministries said. The crash could have occurred due to poor weather conditions. Alexander Shuklin, the Komi prosecutor, was reportedly expected to arrive at the crash site this morning.

HELICOPTER CRASH, WAT BAN **NAMKIEW AREA, THAILAND**

London, Mar 24 - A press report, dated today, states: A Bell 214 helicopter crashed, yesterday, into an open field close to Wat Ban Namkiew, Rattanaburi district, some 70km from Surin, bursting into flames upon impact, killing all nine naval officers on board. The helicopter was one of two belonging to the Royal Thai Fleet's Wing 2, in Rayong province, which left Ubon Ratchathani airport at around 1100 hrs on a flight training programme. They were heading back to U-tapao naval base, in Rayong, when one apparently developed engine trouble. The helicopter suddenly lost altitude and hit the ground before bursting into flames. An eyewitness said the two helicopters were flying close together. One of them then started to sway from side to side before plunging to the ground. Royal Thai Navy secretary Rear Adm Ruengtip Tienthong said smoke was spotted coming from the rear engine of the helicopter before the crash. He said mechanical failure was suspected as the cause of the accident. Navy chief Adm Sathiraphan Keyanont ordered a fact-finding panel set up to look into the cause of the crash.

INCIDENT AT BEN GURION INTERNATIONAL AIRPORT, **ISRAEL**

London, Mar 27 - A press report, dated Mar 26, states: An El Al jet taxiing before take-off at Ben Gurion International Airport filled with smoke on Sunday (Mar $\hat{2}5$), forcing passengers and crew to flee the aircraft on emergency slides, airport officials said. The 128 passengers and crewmembers on the Zurich-bound 737 were evacuated after smoke began billowing out of vents on the aircraft, airport spokesman Yiftach Kramer said. No one was hurt in the mishap, the cause of which was still unknown, he said.

INCIDENT AT ISTANBUL, TURKEY

London, Mar 23 — A press report, dated today, states. An Afghan aircraft skidded off the runway at Istanbul's Ataturk airport today and came to a halt resting on its right wing, a news agency reported. All passengers and crew members were safely evacuated through emergency slides. The Ariana Afghan Airlines flight from Kabul, overshot the runway after it landed, the private Dogan news agency said. None of the 50 people, including 20 crew members, on board was injured, the agency said. It was not immediately

clear what caused the Airbus A300 to skid but the runway was slippery due to light rain at the time of the landing.

London, Mar 25 — Airbus A.300B4-203 YA-BAD, operated by Ariana Afghan Airlines, overran Runway 24 by 30 metres and came to rest on its No 2 engine, close to the airport perimeter fence, on Mar 23.



ATLANTIS

London, Mar 23 — A press report, dated Mar 22, states: NASA enigneers spent the day yesterday studying space shuttle Atlantis to determine how badly it was damaged. As of yesterday, no new launch date was set. The shuttle's external fuel tank was damaged by hail last month leaving several dents which could prove harmful to a potential mission. CBS news correspondent Peter King says NASA has a lot to consider. NASA engineers are still determining the extent of the damage. They must determine if the fuel tank can be

repaired or if they are better off replacing it. King says there will be a lot to repair if thats the route they decide to take. Engineers should be able to make the decision on Apr 10.



SOMALIA

London, Mar 29 — A press report, dated Mar 28, states: Somali businessmen have announced they will stop importing and exporting through the port of Mogadishu because of a dispute over additional tariffs imposed by the interim government. The announcement came after the union of business people in Banadir Province met to discuss a recent double tariff on traders using the port, which has been imposed since the interim government came to power. A spokesman for the union, Abbas Mohamed Duale told Shabelle Radio in Mogadishu that the government had more than doubled the tax and said that for example a sack of sugar which previously carried a tax of \$1 was now being taxed at \$3.60. He said this was something the business people could not afford to pay and they had decided to stop using the port at Mogadishu as a result. He did not disclose the means by which businesses intended importing cargo in future.

WEST AFRICA

London, Mar 26 - A press report, dated today, states. The following delays are reported: Luanda, Angola berthing delays of 20 plus days. Matadi, Democratic Rep of Congo berthing delays of between two and three days. Cotonou, Benin - berthing delays of two days. Tema, Ghana -berthing delays of two days. Takoradi, Ghana - berthing delays have reduced, following a number of measures introduced to ease the situation. These include companies trading in cocoa being allocated set days on which to dispatch trucks with the produce.
