Rocket attack raises fears of new piracy threat off Somalia

UASC handysize vessel hit, writes Marcus Hand

United Arab Shipping Co handysize vessel has been hit by rocket-propelled grenades in a pirate attack 180 nautical miles off the coast of war-torn Somalia.

The accommodation block of the 23,618 dwt Ibn Younos caught fire and was badly damaged when it was hit by the device fired by heavily armed pirates chasing the vessel in a speedboat in the main shipping lane as it headed to Jebel Ali.

The crew escaped the incident unscathed, but piracy watchdog the International Maritime Bureau is worried that this, along with other recent attacks, will see a return of the serious threat that was posed to shipping in the area by pirates in the latter part of 2005.

"We are very concerned that the warlords are coming back to attack ships far out from the

coast," said Noel Choong, head of the IMB's piracy reporting centre in Kuala Lumpur.

In the latest incident the Qatar-flagged Ibn Younos was sailing from Durban to Jebel Ali, when it came under attack at position 01:19.62N, 048:51.92E at 1530 hrs local time on Monday.

According to a report made to the piracy reporting centre, the vessel's second officer realised they were under attack when he heard

A speedboat with three men armed with guns and RPGs ordered the ship to stop, then opened fire on it.

The Ibn Younos' crew raised an anti-piracy alarm and took a zigzag course in an effort to shake off the attackers.

The pirates then opened fire with RPGs aimed at the ship's bridge and hit the accommodation block, which caught fire causing extensive damage to crew's quarters.

The crew succeeded in putting out the fire, and after an hour the pirates gave up the chase.

The attack is the seventh off Somalia this year and the fifth since the beginning of April, prompting worries of a repeat of the series of incidents in late 2005.

At that time ships were attacked on a near daily basis, often while using main ship-ping lanes hundreds of miles from the Somali coast.

Whereas all the other incidents this year have taken place within 12 nautical miles of the coast. the latest attack was much further out.

"We are very concerned about the latest attack as it happened 180 miles from the coast," Mr Choong said.

"We hope this is not a start of the same problems we had more than a year ago that disrupted the main shipping route."

The spate of previous attacks resulted in many ships diverting their courses to be as far away from the Somali coast as possible, increasing both voyage time and fuel costs.

The IMB has informed the coalition naval forces in the area in an effort to step up maritime security.

The bureau has vet to update its advice to shipping broadcast on a daily basis to stay at least 75 miles from the Somali coast where it says there are a high risk of attacks and hijackings.

Fresh rail strike threat looms for Canadian ports

HIPPERS relying on railways to transport their goods to Canadian ports face possible delays and disruptions for the second time this year as another strike looms on an important rail system, starting May 16.

The union representing more than 3,000 workers who maintain tracks on the Canadian Pacific Railway network served a 72-hour strike notice over the weekend after negotiations collapsed on wage

CP Rail indicated it had trained more than 1,300 employees who could replace the 1,200 unionised workers who directly maintain tracks.

Last February, Canadian National Railway adopted a similar practice when conductors and yard workers went on strike.

Eventually the federal government intervened in late April to end the conflict through back-to-work legislation after many industries and ports had suffered from cargo delays.

The Teamsters Canada Rail Conference Maintenance of Way Employees called the strike notice "a sad day for the company and for the country"

William Brehl, the union's president, said he had been hoping for a negotiated settlement.

CP Rail president Fred Green declared that the railway could not meet demands that amounted to "a sub- stantial premium to other agreements that we have signed after fair negotiations".

"They want a wage increase of 4% over four years and CP Rail has offered 3% in line with other contract packages," he said.

ALMIRANTE IRIZAR (Argentina)

London, May 9 - A press report, dated today, states: Damage sustained by the Argentine icebreaker Almirante Irizar when fire broke out on board, is far more serious than originally announced and full repairs could take more than the estimated two years the Buenos Aires press revealed this week. Although when the vessel was finally towed back to Puerto Belgrano Captain Guillermo Tarapow, optimistically declared that "85% of the vessel had been saved", the fact is that not only the generator-room, where the fire started, and the engine-room were razed but it now appears the labs, refrigerated samples, scientific research records, sophisticated equipment and even experts' notebooks were a total loss. According to the Buenos Aires press, Armed Forces Chief of Staff General Daniel Oscar Camponovo presided over an emergency meeting with delegates from the different offices involved in Argentina's Antarctic operations and following a primary assessment of the situation it was agreed that in the most optimistic of scenarios, "it will take over two years to have Almirante Irizar back in action". "We're facing a non declared emergency situation", said

General Camponovo. The icebreaker is the backbone of Argentina's Antarctic operations and a very efficient logistics tool in supplying the country's several bases and stations, including some which can only be reached by breaking through the ice casket. Almirante Irizar's generator-room caught fire in mid April, in the South Atlantic when the vessel was on its closing trip of the 2006/07 Antarctic campaign. Brazil and Britain have offered their Antarctic vessels to help Argentina with its operations in the coming summer campaign (2007/08). The Buenos Aires press further revealed that the helicopter hangar on the Almirante Irizar was also engulfed by fire and spare parts, plus an additional turbine for the Sea King helicopter, have been lost, "leaving the Argentine Navy with virtually a single Sea King and almost no spares". Julio Cesar Urien, CEO of the Rio Santiago dry docks, (one of the possible places to rebuild the Almirante *Irizar*), is quoted by the press saying that the overall job is "relatively simple" because the hull and superstructure have been saved, but the rest, the "heart and brains" of the vessel have to be assembled "brand new from scratch".

AMADEO (Panama)

Bucharest, May 7 — A fire broke out May 2 on board product tanker *Amadeo* (24111 gt, built 1996), which has been at Constantza Shipyard since Dec 13 for conversion work. The fire was noticed by the vessel's crew at about 2200 hrs, in the rope storage room located on the port side in way of the steering-gear room. The vessel's crew immediately began firefighting operations and firefighters from Constantza Shipyard and Constantza Port Administration also attended. The fire was extinguished at 2359 hrs. There were no injuries but the incident resulted in damage to the vessel. -Lloyd's Agents.

ANGELA STAR (Panama)

London, May 4 — Bulker Angela Star arrived Singapore 0925, Apr 26 and sailed 1650 same day.

ASKO (Antigua & Barbuda)

Portsmouth, UK, May 7 — General cargo Asko (3183 gt, built 2005), Papenburg for Emden with wooden trunks, grounded on the Island of Bingum, on the River Ems, at 1700, Apr 22. The vessel grounded crosswise in the River Ems and all attempts to free itself were unsuccessful. The vessel also experienced engine problems. The passing general cargo Danica Rainbow created a large wave in the direction of the bank where Asko was grounded, allowing the vessel to eventually free itself. The vessel continued on its way to Emden at 1830 hrs. Correspondent. (Note Askosubsequently arrived Trondheim Apr 28 and sailed the same day.)

ASPOE (Cyprus)

Gothenburg, May 7 — Examination of of tug/icebreaker *Bohus* revealed the possibility that a textile cloth left behind in the daytank after cleaning

the interior of the tank may have caused the main engine to stop. The crew was new on board with less time to familiarise themselves properly with the vessel and learn how many shackles of anchor chain were out. Crew estimated time to restart engine and waited too long before informing MRCC for assistance, resulting in the grounding, etc. — Westax Marine Services AB.

BOURBON DOLPHIN (Norway)

London, May 3 - A press report, dated today, states: Insurance club Gard P&I issued a statement recently that dealt a blow to any hopes of raising the sunken anchor handling tug/supply Bourbon Dolphin. The Norwegian club said that they wished to do all they could to offer assistance and support to the grieving families of the victims of the tragedy but after consultation with London Offshore Consultants the conclusion was that technically it is "extremely uncertain" if it would be possible to recover the vessel. It lies in about 1.100 metres of water and the club's consultants said that the deepest lcoation of any recovered vessel so far has been 600 metres and that was a much smaller and lighter ship. Other negative factors were the extreme conditions in the location, including difficult wind, wave and current conditions and the unknown condition of the vessel. It was possible its hull had sustained serious damage and it may be partly submerged on the seabed. The consultants concluded that any method that could be attempted would be by its very nature untried and would require "a significant period of time for research, engineering and planning." The vessel appeared not to pose a danger to shipping or the environment, therefore, the state would not be ordering its removal. Without such an order, Gard could not cover the costs to raise the vessel, even if it were technically possible.

CALA PALMA (Italy)

Bremen, May 4 — Refrigerated general cargo *Cala Palma* presently still at Bremerhaven. Recently moved to dry dock No.3 and it appears that finally repairs have started. — Lloyd's Agents.

According to Washington State Ferries, Chelan developed a leak in the cooler used to cool the engine water and vessel will be sent to dry dock. Ferry Evergreen State will replace the Chelan for San Juan routes. That means the ferry will carry fewer cars on the 0600 hrs sailing from Friday Harbour to Lopez Island and to Anacortes in the morning and there will be no stop on Lopez on the 1705 hrs sailing from Anacortes to Friday Harbour. In addition, other adjustments will be made to other ferries. Mumbai, May 9 — General cargo *Eugenia* still at Mumbai port, under High Court arrest. — Lloyd's Agents.

FARAH-3 (Jordan)

London, May 4 — A merchant vessel has reportedly been stripped bare after

grounding off Sri Lanka's north-east coast, in what may be the work of that country's Tamil Tiger rebels. Everything on board general cargo Farah-3 had been systematically looted, the operator has claimed. The insurgents subsequently handed the crew over to the Red Cross, after denying accusations by the military that they had staged a pirate attack on the vessel. Sayed Sulaiman, chairman of reported Jordanian owner Salam International Trading Co, told the BBC Tamil service: "I do not know anyone else to blame except the Tamil Tigers for this incident. "We hear from the parties who are concerned with the ship, the insurance company etc, that ... everything that could be taken like the rice, lights, generators - has been taken from the ship. The ship is now bare." Attempts to secure safe passage for the insurance company and surveyors to visit the vessel have apparently failed.

GALICIA SPIRIT (Canary Islands)

London, May 7 — A press report, dated today, states: Around 30 seafood fishing boats from Mugardos, Fene and Ferrol ports prevented Liquid Natural Gas Carrier Galicia Spirit (94822 gt, built 2004) from entering the port of Ferrol at high tide this morning. It is the first time that a vessel of these characteristics has attempted to enter the sea loch to deliver liquid gas to the recently-constructed Reganosa conversion plant. The protesters claim that the new factory will kill off the shellfish in the area as the water it will pump out will lower the natural water temperature. It is expected that the Galicia Spirit, which is carrying 140,500 cubic metres of liquid gas, will not be able to try and enter port again until high tide this evening at around

London, May 10 - Liquid Natural Gas Carrier Galicia Spirit successfully docked vesterday at the Reganosa regasification plant in the Ferrol river. The vessel had initially attempted to dock on Monday (May 7), but fishermen protesting that it would destroy the seafood and shellfish cultures in the area prevented it from doing so and continued protests had prevented it docking on the four subsequent high tides. However, according to local media reports a large police mobilisation today stopped protesters from mounting their blockade of the Ria de Ferrol estuary, allowing Galicia Spirit, which is operated by Spanish electricity company Union Fenosa and carrying 140,000 cubic metres of gas from Damietta, to berth.

GAVROCHE (France)

Portsmouth, May 9 — French trawler *Gavroche*, GV 555238, 19 m, registered in Guilvinec, sank about 70 km to the west of Conquet at 2100, May 7. The emergency services including a French frigate and helicopter attemped to pump out the vessel which had sustained a major water ingress in the engine but to no avail.

GEORGE T.

(St. Vincent & Grenadines)

Kiel, May 10 — Bulker George T. (91164 gt, built 1990) experienced problems at Schouwenbank, 15 miles from Westkapelle, Netherlands, yesterday morning. The incident occured in blustery weather, when the vessel's anchor chains got entangled while trying to raise anchor. Tug Zeebrugge was sent to the vessel which was thus stuck fast in its anchor position. — Correspondent.

GIANT I (Panama)

Antalya, May 9 - Fire broke out on yacht *Giant I* at 0630, Apr 26, due to an electrical malfunction. Passengers on board evacuated. Crew evacuated the vessel after fire fighting failure. Tugs *Aytak* and *Dilburnu* from the port of Antalya successfully conducted salvage operations, putting out the fire and cooling the vessel. Fire is out, crew returned to the vessel and extent of damage to vessel is unknown, however, it is reported to be rather severe and vessel would not be able to sail out by itself. Giant I is still at anchorage with Dilburnu and environmental services from port of Antalya on stand-by. -Lloyd's Sub-agents.

GOURINIS (France)

Lorient, May 5 — According to CROSS Etel this morning the refloating of ferry *Gourinis* started yesterday morning at the order of the Prefecture Maritime in Brest. According to a press report, dated yesterday, two investigations have been required by the director of the "Affaires Maritimes du Morbihan." The first at the request of the "Bureau Enquete Accident" about the administrative and technical matter, the other being a nautical investigation. The wreck could be brought back to the port of Port Maria, Quiberon. — Lloyd's Agents.

GRETA KOSAN (Isle of Man)

Oporto, May 3 — Local agents of Liquid Petroleum Gas Carrier *Greta Kosan* have advised that the vessel is still under repair at Viana do Castelo. Repairs are expected to be completed by the middle of May. — Lloyd's Agents.

GULF PRIDE (Panama)

Djibouti, May 6 — General cargo *Gulf Pride* is still in Djibouti under arrest. — Lloyd's Agents.

HARPOON (Philippines)

ISAFOLD (Denmark)

Kiel, May 7 — Fishing (general) Isafold (2499 gt, built 2006) was towed to Vagur on Apr 25 by the Coast Guard vessel Tjaldrio after the vessel's trawl caught in its propeller while fishing for blue whiting south of the Faroes. It took divers more than two days to free the 150 metres of trawl from the propeller and propeller shaft. — Correspondent. (Note — Isafold subsequently passed Skaw, southbound, May 3.)

IWASHIRO (Panama)

the end of July, with construction to begin upon delivery of the first replacement steel beam, which is set for May 18, S.C. Department of Transportation engineers said vesterday. The contractor hired for the repairs told DOT officials that steel has been obtained and a steel fabricator in Augusta, Ga, is beginning to manufacture the total of five support beams that need to replaced on the bridge damaged when a crane on barge *Mobro 139* being towed by tug *Sara* Kaitlin, struck its underside last week. "We have not seen any additional deterioration," said Robert Clark, DOT engineering administrator for Beaufort County, of inspections since the bridge was opened again to limited traffic Wednesday afternoon (May 2). "The bridge is not in any danger of collapsing." Clark said the contractor gave DOT a 10-week schedule to replace all five beams, and they hope to keep one lane open to traffic for passenger cars and pickups without trailers throughout the repairs. The contractor has assembled crews for the job and is checking on equipment availability, Clark said, but DOT hasn't received a detailed work schedule with the hours the crews will work. However, he said he expects it to be treated as an emergency. The restricted hours for recreational boating traffic through the swing bridge will remain the same and seem to have been working well, but the times remain flexible, Coast Guard Cmdr. Casev White said. Coast Guard investigators are finishing up the first round of investigation into the Apr 26 collision that damaged the McTeer bridge, White said, and a few more details were released yesterday. Sara Kaitlin towed the barge carrying the crane under two bridges with the same height limit as the McTeer bridge, 65 feet at high tide, without incident, according to a Coast Guard press release. Sara Kaitlin began its journey early Apr 26 out of Charleston towing several barges and some equipment owned by CML Equipment Company, which is connected with Charleston-based Marinex Construction Company, according to the release, and it passed under the Limehouse Bridge to Johns Island at 0145 hrs without incident. Sara Kaitlin then met up with tug William Breckinridge, also owned by Savannah Marine Services, and the crane was used to split up the tow, which left Sara Kaitlin towing the single barge with the crane and dredge pipe, the release states. The crane was stowed after the tow was split, and both tugs continued south and passed under the Dawho River Bridge outside of Edisto at 0920 hrs without incident, according to investigators. Sara Kaitlin passed under the McTeer bridge at 1930 hrs, and the crane struck it, but the release states the tug was allowed to continue to Savannah after reporting the accident to local authorities. Coast Guard officials said they continue to gather the details of the crane use, stowage procedures and tidal influence and won't be able to release the cause for another few days.

Charleston, SC, May 7 - Understood barge Mobro 139, owned by Marinex Dredge Co, Savannah, was being towed by a tug, owned by Savannah Towing Co, at the time of the incident. Both the crane and the tug remain in Savannah. The crane reportedly struck and damaged three (of the five) bridge gerders, one of which was heavily damaged. Repairs are under way and are anticipated to be complete in two months' time. In the meantime, all vehicle traffic on the bridge has been somewhat restricted. — Lloyd's Agents.

MSC NAPOLI (U.K.)

London, May 8 — Pressure is growing for ship manifests to contain more detailed cargo information following lessons learnt from the container carrier MSC Napoli clean-up. Salvors and contractors involved in the huge operation to remove, inspect and process containers from the beached vessel say their work would have been easier if there was better understanding of cargo characteristics. "Our biggest problem is not enough information on the manifest," said David Duffield of marine consultants BMT Murray Fenton, the on-site representative for $MSC\ Napoliis\ P\&I$ insurer, the London Club. Each container has to be opened and its contents checked, a dangerous task at any time. When the cargo may have been damaged, contaminated or mixed with salt water the risks are even greater. Despite earlier suspicions there appears to be little evidence so far of wrongly declared or overweight cargo. The Maritime and Coastguard Agency, which is overseeing the salvage effort, has also praised the vessel's charterer, Mediterranean Shipping Co, for producing the manifest and bay plan so quickly. "The charterers did a fantastic job," said Robin Middleton, the Secretary of State's Representative who is in overall charge of the whole operation to remove fuel and cargo from the ship and then clear the wreck. The manifest was produced in record time and within five days the salvors knew exactly what was on board. That included the usual cross-section of cargo found on any container ship, including hazardous chemicals, medicines. consumer refrigerated produce, car parts and personal effects. Slot charterers Hapag-Lloyd, Italia Marittima and H Stinnes had cargo on board as well as MSC. In total, the ship was loaded with 2,318 20-ft and 40-ft containers at the time of the accident, of which 853 were subsequently lifted off the deck and taken to Portland, Around 1.200 have so far been extracted from the holds. A further 76 fell overboard when the vessel was beached and washed ashore, 19 were submerged and another 19 are still unlocated, although some could be trapped under the vessel. Fewer than 200 are still on the vessel in the hold closest to the fracture, with salvors SMIT hoping to lift them out within three weeks or so. Pontoon Viking Barge 5, with heavy lifting equipment, is arriving at Portland about every 36 hours with an average of 30 containers

from MSC Napoli. Many are waterlogged, oily, crushed and dented. MSC's feeder vessel, container carrier MSC Grace, is calling from time to time at Portland, where around 200 containers have been cleared for onward shipments and are ready for collection, It is scheduled to arrive in the middle of this week to load another block. Cargo that was too badly damaged or spoiled is being taken to recycling plants or landfill sites across the country. A consignment of 20,000 litres of milk, for example, can only be processed by one facility in Sheffield where the cartons are separated from the liquid, which must be solidified before disposal. Apart from insufficient detail about cargo characteristics on manifests, the accident has also thrown up another problem. In many instances there are no contact details for the cargo owner, says Mr Duffield. In the case of MSC Napoli, for example, some packages were just due to be delivered to a PO box. A large amount of freight on MSC Napoli had insufficient delivery instructions or consignee information, slowing the whole process of clearing the backlog that, at times, has threatened to hold up the whole salvage programme.

London, May 9 - A press report, dated today, states: Salvage experts trying to decide what to do with the beached Container Carrier MSC Napoli say that one option under consideration is to tow the vessel to deep water and sink it. Work has been going on to recover its cargo of containers, and the last of these is expected to be removed in the near future. Although the vessel has not yet been declared a Constructive Total Loss, salvors say that its size presents a major problem. It has a normal draught of 19 metres, and there is no guarantee that it can be refloated sufficiently for it to be towed to a suitably deep dock. Towing it out to deep water and sinking it, after all pollutants have first been removed, may be the only solution.

NAUTILUS (Netherlands)

London, May 4 — A SMIT Salvage BV report states: Hopper dredger Nautilus capsized Nov 30 during dredging activities at the port of Pointe Noire. Lying partly submerged, almost upside down at a water depth of approximately 12 metres, a site survey was performed whereafter SMIT Salvage was contracted for the parbuckling and refloating operation. The salvage method of SMIT Salvage was to parbuckle and refloat the vessel with the assistance of SMIT's sheerlegs Taklift 7 utilising both the lifting and the pulling capacities of the crane. Nautilus was pulled 180 degrees around to an upright position. The pulling wires were connected to the vessel's bottom from where they passed under Nautilus to the surface again on

the starboard side of the vessel and lead to winches on Taklift 7. Before the actual parbuckling started, the vessel was secured at its port side by means of wires and to delta flipper anchors as to prevent the vessel from sliding over the seabed. The normal operations in the port of Pointe Noire were restricted for only a couple of days because of the parbuckling operation. After the successful operation, Nautilus was refloated by means of lifting by Taklift 7 and dewatering of the dredger's compartments. Subsequently it was towed into a safe berth at Pointe Noire by the URS tug Banckert. SMIT's divers restored the watertight integrity by means of patching. After the clean up of debris at the location of the sinking, the Nautilus project was finished on Mar 21.

NAZIMUDDIN (Bangladesh)

Karachi, May 4 — Chittagong Port Authority has received the report from the inquiry committee about the collision between general cargo Nazimuddin and general cargo Titu-5 in Chittagong port channel Apr 14. It held the masters of both vessels responsible for the collision. "I can confirm that three employees at the centre of the investigation have been terminated. They were notified in writing as of Apr 24," B.C. Ferries spokesman Mark Stefanson said. Stefanson said the ferry workers' union has the right to appeal the dismissals and the individual employees can also appeal. The Transportation Safety Board has yet to release its report and the Royal

Canadian Mounted Police are still investigating. The firings were a result of the B.C. Ferries report that concluded human error was to blame for the sinking, saying the bridge crew failed to make a critical course correction, allowing the vessel to run straight into Gil Island. Two of the three workers refused to co-operate with B.C. Ferries' investigators.

London, May 7 — A press report, dated today, states: A federal report into the sinking of passenger ro/ro Queen of the North last year has been delayed. The Transportation Safety Board spent more than \$600,000 investigating the loss of the ferry, which left two people missing after striking an island south of Prince Rupert. The board investigators sent a draft of their findings to an undisclosed list of reviewers several weeks ago. TSB spokesman John Cottreau said one of those parties had been granted a 30-day extension to respond to facts in the draft. Cottreau could not say when the final Queen of the North report would be released to the public. The board must reply to each of the draft reviewer's comments in writing, those comments and responses will then be assessed by staff and a redrafted report will go to the board for approval. It is now likely the final report will not be released before the end of June

London, May 9 - A press report, dated today, states: An alarm that should have alerted two bridge crew members that passenger ro/ro *Queen of* the North was off course and about to slam full-speed into an island was turned off. The alarm, which is connected to a global positioning system, a satellite-based navigational aid tracking the vessel's position, was switched off by a crew member on a previous shift, a source close to the investigation confirmed yesterday. The crew in charge when Queen of the North sank had also dimmed the electronic chart system's monitor displaying the ferry's course and didn't fully understand how to operate a recently installed switch governing the autopilot and manual steering, according to a Transportation Safety Board advisory released last year.

London, May 10 - Somali pirates have hijacked a general cargo vessel and are holding it and its 16 strong crew for ransom. This is the latest in a number of incidents that have followed the overthrow of the Islamic Courts regime in much of the country which had more or less suppressed piracy. According to the ICC International Maritime Bureau's latest weekly report, this latest incident happened last Thursday (May 3) 12 miles off Mogadishu at 0700, local time. The Ministry of Defence said Severn's rigid inflatable boat chased the trawler at full speed for 18 miles. The crew, led by Lt Simon Austin, managed to board the trawler while both vessels were still moving. On board, they found hidden freezers full of undersized sole which had already been prepared and filleted. The 11-hour operation ended when Severn escorted the vessel into Tyne. The captain and owner were fined by the Fisheries Court in North Shields today. The vessel was also ordered to forfeit its nets, which were illegally adapted using "blinders" to reduce the size of the mesh. It was further ordered to forfeit its illegal cargo of undersized sole and was banned from the fishing ground for five

HOUSTON AREA, TEXAS, UNITED STATES

London, May 9 - A press report, dated May 8, states: Crews have cleaned up fuel that spilled out of a ruptured pipeline in north-west Harris County, news reports said today. Harris County sheriff's deputies said a construction crew ripped a two-inch extension of an eight-inch pipeline at about 1330 yesterday. ExxonMobil officials said nearly 3,000 gallons of fuel poured out of the Baytown-Irving pipeline. Crews repaired the gash and are using special equipment to determine if there are any hairline cracks. Investigators said tests showed there is no environmental danger to the area. "We basically had non-detect levels of hazardous concentrations to the public," said B. J. Young with ExxonMobil. Several roads in the area were closed to traffic.

KIEV AREA, UKRAINE

London, May 8 Ukrainian authorities said today that an explosion along a main trunk pipeline responsible for transporting Russian and central Asian natural gas would not disrupt supplies to customers in Europe. A pipeline located just south of Kiev caught fire today. Investigators had not ruled out foul play, but said it could have been ignited by a leak in the ageing Soviet-built pipeline. The energy ministry said the supplies had been redirected to parallel pipelines. The pipeline affected handles oneeighth of supplies pumped via Ukraine to Europe. "At the moment we are increasing transit through alternative routes and boosting supplies from underground storage facilities near the border with Europe," Mr Borodin added.

PRUDHOE BAY, ALASKA

New York, May 9 - Two reports on the cause of one of Alaska's worst onshore oil spills, commissioned by BP Plc, blame the oil company's costcutting and management culture for the accident, people familiar with the reports said. The reports come after a US congressional committee said documents turned over by BP suggest "draconian" cost cutting at the British company's Alaska operations led to the March, 2006, rupture of a corroded oil pipeline at Prudhoe Bay, spilling at least 200,000 gallons of crude oil onto the Arctic tundra. "The reports speak to the fact that top-down cost cutting was going on without any risk analysis," said a congressional aide familiar with the documents. The reports along with BP documents and e-mails describing cost cutting scenarios in Alaska are expected to be the focus of a congressional hearing set

for next Wednesday (May 16). "We don't plan to release the report until we've had an opportunity to meet the members of the committee and discuss their contents with them," said BP spokesman Ronnie Chappell. — Reuters.

SURABAYA AREA, INDONESIA

London, May 9 — A press report, dated May 8, states: Sludge has burst through an embankment built around Indonesia's disastrous "mud volcano, flooding a main road, an official said today. Officials said a large crack had formed in the dyke, which was designed to hold back the massive mud flow in East Java. "We have managed to repair the crack but the road is still impassable," said a government spokesman. "The road should be said a government opened later tonight after we pump all the muddy water away," Muhammad Zulkarnain said. The embankment was built after the steaming crater, located near Indonesia's second-largest city of Surabaya, began spewing mud in May last year following exploratory gas drilling. The sludge has inundated some 600 hectares, including many homes and factories, leaving 15,000 people homeless. Indonesian experts have tried to halt the flow by plugging the crater with chains of concrete balls, a bold plan that some say will not work. The embankment also repeatedly gave way when officials tried unsuccessfully to channel the flow to a nearby river. Several local nongovernmental groups have taken legal action against the local drilling firm, PT Lapindo Brantas, which apparently pierced a layer of strata under pressure at a depth of several thousand feet.



DUBAI, UNITED ARAB EMIRATES

Dubai, May 5 - An oil slick today forced authorities to close beaches along a stretch of Dubai's Gulf coast lined with luxury hotels. "We are cleaning up after a tar slick washed ashore. The beach is closed until tomorrow. This happens sometimes in this area but this is the worst I have seen in several years," an employee at a five-star hotel said. "The public beach near our home is closed and there is a crew working with shovels and plastic bags to clean it," a resident said. The origin of the slick was not clear and coast guard officials could not be reached for comment. Environmentalists say most oil pollution on the beaches is due to spillage from oil tankers in the Gulf. An estimated 50,000 vessels passing through the shallow waterway discharge around 30 million cubic metres of ballast water every year, according to the Emirates Environmental Group. Today's slick appeared to be concentrated in the Jumeirah area, site of the Burj al-Arab and Jumeirah Beach luxury hotels, while hotels further east in the Marina area were not affected, according to staff. — Reuters.

GEORGIA

Portsmouth, UK, May 4 — Combined chemical and oil tanker *Alios Triton* (3997 gt, built 2005) was detained at Batumi yesterday in respect of (alleged) pollution in coastal waters. — Correspondent. (Note — According to Lloyd's MIU AIS *Alios Triton* was moored at Batumi at 0804, UTC, today.)

London, May 10 — A press report, dated May 9, states: State ecology and Coast Guard officials are scrambling to clean up a diesel spill from a boat into Skagit Bay. The Department of Ecology says the diesel was discovered late last night in the La Conner Marina coming from a 40-foot private boat. The Coast Guard flew over the scene this morning and says the spill is mainly concentrated in the slips of the marina. It wasn't immediately clear how much fuel had spilled. The owner of the boat is taking responsibility for the spill.

Chittagong, May 7 — There are currently no cautionary signals in effect for sea or river ports. — Lloyd's Agents.

CANADA

London, May 8 — A press report, dated today, states: Thick, heavy ice which continues to block the shoreline of eastern Newfoundland and Labrador is causing what some are calling a crisis situation in the inshore fishery. In some areas boats cannot leave port, while in other areas boats out on the water are unable to land their catches at their regular ports, creating a shortage of work at plants. It is estimated that thousands of fishermen and plant workers will be affected by the delay in the start of the lobster and crab fishery. One lobster fisherman in Long Island said that ice conditions in Notre Dame Bay were making it impossible to start the lobster fishery. The fisherman said pots from the crab fishery that opened on Apr 1 were still on local wharves. The Food Fish and

Allied Workers' Union is still trying to convince Ottawa to extend EI benefits because of the harsh ice conditions. Union president Earle McCurdy wrote to federal minister Monte Solberg last month and said those affected were facing dire financial circumstances. The union said the ice conditions were the worst it had seen in 20 years.

SUBTROPICAL STORM "ANDREA"

London, May 9 — A press report, dated today, states: The first named storm of the year formed today off the south-eastern US coast, more than three weeks before the official start of the Atlantic hurricane season. forecasters said. Subtropical Storm "Andrea" had top sustained winds around 45 mph this morning and did not appear to be much of a threat, the National Hurricane Centre in Miami said. Still, a tropical storm watch was issued for parts of Georgia and Florida, meaning tropical storm conditions are possible within 36 hours. "We're not looking at this system strengthening significantly," said Richard Pasch, a senior hurricane specialist at the centre. "We're not viewing this as a major threat." At 1100, EDT, "Andrea" was centred about 140 miles south-east of Savannah, Georgia, and about 150 miles north-east of Daytona Beach. The storm was moving west at about three mph. Forecasters said no significant rain from the storm was expected to fall over land through at least tomorrow morning. However, wind-driven waves have been causing beach erosion in South Carolina, Georgia and Florida and the ocean has lapped at beachfront homes and condominiums. Subtropical systems are hybrid weather formations that are usually weaker hurricanes and tropical storms.

London, May 10 — Following received from the Meteorological Office, dated today, states: Subtropical storm "Andrea" located near lat 30.4N, long 80.0W or about 135 miles, southsoutheast of Savannah at 0900, UTC. The storm is drifting southwestward and little motion is expected for the next 24 hours. Maximum sustained winds are near 40 mph with higher gusts. Some weakening is forecast during the next 24 hours. Winds of 40 mph extend outward up to 105 miles. "Andrea" is expected to produce total rainfall accumulations of one-half to one inch along coastal areas of the southeastern US.

UNITED KINGDOM

London, May 9 — A press report, dated May 8, states: High winds in the North Sea closed a major container port for several hours this afternoon. Quayside cranes at the Port of Felixstowe were unable to work and available space for lorries filled up, a police spokeswoman said. Trinity and Landguard terminals were closed but Dooley which handles roll-on roll-off vessels remained open. Lorries bringing containers to the port are currently causing local traffic congestion inside the port.

Political & Civil Unrest

NIGERIA

London, May 3 — A press report, dated today, states: The second attack and kidnapping this week at an oil facility in the Niger Delta has been reported. In the latest incident, local militants attacked the FPSO Mystras (Okono Terminal) in the early hours of this morning. Six expatriate workers were kidnapped, and their whereabouts is currently unknown. The terminal operators have declared a 'force majeure'. The incident is expected to affect the handling of an export tanker due to arrive at Okono Terminal tomorrow. The attack on FPSO Mystras comes just two days after operations were suspended at FSO Oloibiri, in the Pennington Terminal area, after an attack in which six crew members were kidnapped on Tuesday morning (May 1). In addition, eight Filipinos, three South Koreans and a Nigerian employee were abducted early yesterday from Afam power station, about 20 miles northeast of Port Harcourt, according to a statement from Daewoo Engineering and Construction Co. and in a third incident, a Dutch man was kidnapped from a bar in the town of Warri in southern Nigeria overnight, a witness said today.

Lagos, May 3 — The Nigerian

Lagos, May 3 — The Nigerian militant group MEND said all the hostages taken from an Italian-operated offshore oilfield earlier today had been released. The self-styled leader of the Movement for the Emancipation of the Niger Delta (MEND) said his group had not intended to take more hostages, having seized six foreign workers from a U.S.-operated oilfield on Tuesday (May 1). — Renters

London, May 6 - A press report, dated May 5, states: The Nigerian National Petroleum Corporation (NNPC) has declared a force majeure on the exports of 50,000 barrel per day (bpd) from the Okono-Okpoho oilfield following Thursday's (May 3) attack on non specific tanker FPSO Mystras (76053 gt, built 1976), a Floating Production Storage and Offloading vessel by armed militants in the Niger Delta. According to report, the force majeure will affect a tanker that was due to berth at the field today. The operatorship of the Okono-Okpoho oil field was only recently transfered to the NNPC after more than six years in the hands of Italy's Saipem and SBM Offshore. The latest declaration takes the total oil production halted due to militant attacks in the oil-rich region to about 665,000 bpd. FPSO Mystras vessel is supplied by crude oil coming from Okono and Okpoho fields jointly producing 65,000 b/d, of which Eni equity is 11,500 b/d. Eni is undertaking all the due controls in order to get the

production back to normal in the shortest time possible. Eight of the floater's crew were briefly taken hostage in the raid. They were released six hours after being abducted from the facility, which is moored at the field, about 55 kilometres off Port Harcourt. The dreaded group, Movement for the Emancipation of the Niger Delta (MEND) often claims responsibility for most of the attacks, including the kidnapping, last year of three Italian workers of Eni. The captors often seek ransom payments from companies where the foreigners work before releasing their victims. The resurgence of abduction of foreign workers came barely one month after the militants freed the last set of hostages in their camp.

London, May 7 - A press report, dated May 5, states: Gunmen abducted a British oil worker from a US-owned drilling rig off Nigeria's coast, triggering a security alert at a nearby oil export terminal today, authorities said. The Briton was taken from the Trident 8 rig operated by US-based Transocean off the coast of the state of Bayelsa, in the latest in a string of abductions that have disrupted oil supplies from the world's eight largest exporter. The attackers triggered a security lockdown at the nearby Brass crude oil export terminal, operated by Italian oil company Agip, security sources said.

Lagos, May 7 — Villagers with sticks and machetes staged a protest at a major US-operated oil production facility in Nigeria today, forcing it to halt 42,000 barrels per day output, authorities said. It was the latest in a string of attacks on Western oil industry targets in the world's eighth largest exporter, which has curbed Nigerian output by a quarter and helped fuel a global oil price rally. The protest at the gates of Chevron's Abiteye flow station in the western Niger Delta, which feeds the 160,000 bpd Escravos export terminal, was triggered by alleged delays in compensation for an oil spill. "There is a community protest. They are carrying sticks and machetes, but the place is full of government security forces who were drafted in over the weekend. The company has not lost control of the facility," a security source said. Chevron said 42,000 bpd in oil output was hit by the protest. Talks have already begun and the company expects the crisis to be resolved quickly, said spokesman Femi Odumabo. "Community leaders and elders are very supportive of Chevron, and they are intervening. I think it will be brought to a close today or tomorrow," he said. Spills are one source of constant friction between oil companies and communities in the Niger Delta. Companies blame spills on criminal gangs illegally tapping oil from their pipelines, while communities blame the companies and often demand substantial compensation. Before demand today's dispute, unrest and militant attacks on oil facilities in other parts of the delta had already shut 652,000 bpd, or a quarter of the OPEC member

nation's total capacity. Kidnappings of foreign workers have also surged recently, with 28 foreigners abducted in six incidents in the last seven days alone. Eight have been released. Viktor Goncharov, counsellor at Russia's embassy in Nigeria, said kidnappers who seized a Belorussian woman had demanded \$1.2 million for her release, according to Russian news reports. The Philippine government warned families of eight Filipinos and three South Koreans abducted last week against holding direct negotiations with their Foreign abductors. Affairs Undersecretary Esteban Conejos met families after one woman got a mobile phone call from her husband asking her to raise \$1 million ransom for their safe release. — Reuters.

London, May 8 — A militant group active in southern Nigeria says it has bombed three major oil pipelines. The Movement for the Emancipation of the Niger Delta (Mend) said it had attacked pipelines in Bayelsa State. The claim has not been verified. The group has led several attacks on oil facilities and has abducted foreign workers in its campaign to win a larger share of the region's oil wealth.

London, May 8 - A press report, dated today, states: Nigerian rebels have blown up three oil pipelines in the country's south delta, forcing Italian oil giant Eni to halt production from two oilfields. The Movement for the Emancipation of the Niger Delta (MEND) said in an email it bombed the pipelines to embarrass President Olusegun Obasanjo in his last days in office and vowed to carry out more attacks in the world's eight-largest crude exporter. Oil exports from Africa's top producer were already down by about 700,000 barrels per day (bpd), or a quarter of total capacity, before the latest attacks. Eni says production from two oilfields, Akri and Oshi, has been suspended. It did not detail the volume of oil affected and says it has already started repairing the pipelines which feed its 200,000 bpd Brass oil export terminal. Industry sources say they had detected oil

spilling from the pipelines.
London, May 9 — A press report, dated May 8, states: Oil rebounded towards US\$65 a barrel today as fresh attacks on Nigeria's oil industry interrupted a six-day losing streak that had driven prices to their lowest since Mar 26. Militant raids have shut about a quarter of output in Africa's biggest producer. Fighters from the Movement for the Emancipation of the Niger Delta (MEND) said today they had destroyed three major oil pipelines. The MEND said Agip's Brass terminal, which normally exports about 200,000 barrels per day (bpd), had been affected. The İtalian firm said it had suspended production at two oilfields. Sources at companies due to lift cargoes said they were waiting for word. There had been optimism in some quarters that Nigeria's presidential election last month would mark the start of a recovery for the country's oil industry.

London, May 9 — A press report, dated today, states: Heavily-armed

gunmen kidnapped four US oil workers from a barge off the Nigerian coast near Chevron's Escravos crude export terminal today, a US diplomat and Nigerian security sources said: "Armed men on two speed boats with rifles and rocket-propelled grenade launchers boarded the barge. Four American personnel were abducted."

London, May 9 — A press report, dated today, states: Gunmen seized four American workers as violence escalated in Nigeria's southern petroleum-producing region, a Chevron spokesman said today. The attackers, carrying assault rifles and rocketpropelled grenades, stormed a vessel carrying the workers in the southern Niger Delta minutes before midnight Tuesday, two industry officials said. Chevron Corp. spokesman Femi Odumabo said the four kidnapped workers were subcontractors with US citizenship. Another vessel in the same area, supply Walvis 6 (1070 gt, built 1982), was also attacked and robbed, A crew member reported missing was later found hiding on the vessel. "This later found hiding on the vessel. is just a piracy, robbery case, Odumabo said. Despite last week's attack, in which six Chevron employees were taken hostage, he said the company did not feel singled out as a target. "It's not directed at any one company," he said. Oil prices rose today after the seizure. Light, sweet crude for June delivery rose 12 cents to \$62.38 a barrel in electronic trading on the New York Mercantile Exchange by afternoon in Europe. June Brent crude was up 45 cents at \$65.99 a barrel on London's ICE Futures exchange.

SOMALIA

London, May 10 - A press report, dated May 9, states: African Union (AU) peacekeeping troops stationed in Somalia intend securing key points around Mogadishu including the port to prevent further attacks and ambushes from armed militants opposed to the interim federal government. The AU peacekeepers took over control of the city three weeks ago from Ethiopian soldiers who were largely responsible for forcing the Union of Islamic Courts to abandon the city. Since then however there has been sporadic fierce fighting in the city with parts being mortared by insurgents opposing the interim government and the Ethiopian troops. According to the commander of the AU forces, the seaport is to be fully secured with additional Ugandan peacekeepers who will be stationed in the port. The airport has similarly been secured and a number of armoured vehicles have been observed in the area of the harbour. A main road in the northern suburbs of Mogadishu has been demined - this was the scene of some of the heaviest fighting up to a month ago.

SRI LANKA

Colombo, May 4 — Sri Lanka's civil aviation authorities are to suspend night operations at the country's only international airport following Tamil Tiger rebel air raids near the capital Colombo, officials said today. The

Tigers mounted a pre-dawn raid on oil facilities north of the capital on Sunday (Apr 29), their third such attack in a month using light aircraft smuggled into the country by boat in pieces, and the Air Force has been unable to shoot them down. The Tigers have also targeted an air force base adjacent to the international airport, with which it shares a runway. "Due to the prevailing situation, to minimise inconvenience caused to airline operators and passengers, the airport will close starting from May 9, between 2230 hrs and 0430 hrs the following morning," the duty manager at Bandaranaike International Airport said. Singapore Airlines and Malaysian Airlines are among carriers which have already rescheduled their flights to daytime hours as a security precaution. Reuters.

London, May 7 - A press report, dated May 5, states: A number of Tamil Tiger rebels have been killed in a sea battle off the north-eastern coast. The navy said it sank two Tamil Tiger vessels, part of a flotilla of 26 rebel vessels, and killed at least 10 rebels. The Tigers said no vessels were sunk and they repelled the attack, although they admitted three members had died. Military spokesman Brig Prasad Samarasinghe said the rebel flotilla, sailing south from Mullaitivu, included 10 large and 12 small vessels, accompanied by four "suicide boats" used to ram naval vessels. Two sailors were slightly hurt, he said. The Tigers' spokesman, military Rasiah Ilanthirayan, said that after three hours of fighting, the navy ships retreated to their base in Trincomalee harbour. This month the navy said it had destroyed the headquarters of the Sea Tigers in Mullaitivu. The Tigers said what was hit was the building of a charity that makes artificial limbs for landmine victims.



FORTUNA I (Latvia)

London, May 7 - A press report, dated today, states: The International Transport Federation (ITF) has claimed 11 crew members onboard general cargo Fortuna I off the Louth coast are effectively prisoners, unable to move from the quay wall of Greenore harbour until they were paid salaries withheld from them for the previous four months. The vessel was carrying 1,750 tonnes of steel bars destined for the Irish market and the vessel's crew refused to move it. The ITF succeeded in obtaining arrears of pay for the men up to the end of March but the strike action continued until the guarantee of continued pay and conditions was secured. However, the crew were persuaded to unload the Fortuna I's cargo of steel bars while their ITF representative Ken Fleming was involved in helping the crew of another

vessel, and before he returned it was ordered to leave Greenore Harbour. Since then it has remained moored at the entrance to Carlingford Lough. The vessel was inspected on Apr 4 by the Department of Transport, which found it not to be seaworthy due to inadequacies in the ventilation system and lifeboats. The ITF said the ship is now being prevented from re-entering Greenore because authorities believe the vessel's owners cannot pay berthing fees and it will take up valuable berthing space. It cannot return to Latvia because the nation's embassy has told the ITF they will not let it berth as licences have expired. Mr Fleming said: "What makes the situation on the *Fortuna I* worse is the lack of co-operation and seeming indifference of the Latvian and Irish authorities to the plight of these 11 seafarers. They have been literally stranded with no immediate hope of being paid or returning home." The ITF is demanding that either the ship be reexamined by Irish authorities and allowed to enter an Irish port again, or it is going to the High Court to have the vessel seized so the crew can be taken off and sent home.

London, May 8 - A press report, dated today, states: Latvian general cargo Fortuna I, stranded off the Louth coast in a dispute over safety, will return to land late tonight, the International Transport Federation (ITF) has confirmed. Dundalk Harbourmaster Captain Frank Allen today agreed to allow the Fortuna I and its 11-man crew to berth for an unspecified period. The vessel has been stranded off the Irish coast since Mar 26. ITF inspector Ken Fleming said the move marked progress. "The ITF will facilitate a number of interested parties we have been in contact with, in the shipping industry, to come together and make the necessary arrangements to put the Fortuna I back into service." Port authorities at Greenore, Louth, refused the crew access and the vessel the permission to sail home because of safety concerns over lifeboats and ventilation hatches. After the 11 crew unloaded the vessel's cargo of steel bars, the Fortuna I was ordered to leave its berth and had been moored at the entrance to Carlingford Lough ever since. Mr Fleming said the Irish Coast Guard had ordered the boat's detention but had not returned to inspect repairs. It is understood that Latvian authorities are refusing to allow the vessel back home until safety concerns are resolved.

IRAQ

London, May 10 — Iraq's largest oil workers' trade union will strike today, in protest at the controversial oil law currently being considered by the Iraqi parliament. The oil law proposes giving multinational companies the primary role in developing Iraq's huge untapped oilfields, under contracts lasting up to 30 years. Oil production in Iraq, like in most of the Middle East, has been in the public sector since the 1970s. The Union, representing 26,000 oil workers, has held three previous strikes since

2003, each time stopping exports, for up to two days at a time. The announcement of the strike has spurred negotiations with the Ministry of Oil, which are ongoing.

ITALY

London, May 4 - A press report, dated today, states: A strike by Alitalia flight attendants caused havoc for passengers yesterday, with the national carrier forced to cancel more than 350 flights. The 24-hour stoppage, which began at midnight, led to the cancellation of 202 domestic flights and 154 international ones. It was called by air transport unions over stalled contract renewal negotiations, local media reported. In particular, the unions are demanding inflation-busting pay rises for the loss-making carrier's flight attendants and better conditions for pilots staying in certain long-haul destinations. Unions are due to resume their talks with Alitalia management early next week.

PAKISTAN / AFGHANISTAN

London, May 7 — A press report, dated today, states: Negotiations between the Afghan government and the truckers who have been on strike for the last nine days have reached a successful conclusion but the truckers have asked for a written assurance of the acceptance of their demands before they end the strike. Around 15.000 heavy trucks transporting petroleum, edible goods, construction materials and other goods for NATO forces and Afghanistan are stopped on both sides of the Pakistan-Afghanistan border. The truckers' demands include a reduction in the taxes levied by the government Afghan and the elimination of illegal taxes charged by Afghan warlords at various points on the highway leading from Torkham to Kabul During the nine-day strike the supply of goods to NATO forces and Afghanistan had completely halted and the truckers were determined to continue their protest for an indefinite period if their demands were not met. Afghan Goods Transport Association chief Haji Abdul Rehman said that they held negotiations in the Nangarhar Province of Afghanistan with Gov Gul Agha Sherzai and Afghan commanders. delegation of the truckers' association has also been dispatched to Kabul, where they will hold further negotiations with high officials. "We are expecting some positive results within a couple of days," Rehman said. Rehman was taken into police custody this weekend in the Pakistani city of Peshawar. The police have said that he would be released on bail in a day or so. He faces charges for parking heavy trucks on the roadside and causing traffic jams in the city.

SPAIN

London, May 9 — Shipyard workers brought the city of Vigo to a standstill over the weekend (May 5-6) as they escalated a strike over labour conditions. In scenes reminiscent of the widespread conflict three years ago when state-owned Izar was privatised,

workers blocked roads with burning barricades in the Galician city. Yesterday, in the fourth consecutive day of indefinite industrial action, about 1,000 workers gathered in the centre of Vigo and urged the government to intervene. Union leaders say companies in the sector are not complying with the terms of a collective labour agreement covering the region's yards. In a statement on Monday (May 7), Asime, the association that brings together companies from across the sector in Galicia, urged unions to adopt a less conflictive approach to the dispute. It warned that Galicia's image as a reputable shipbuilding centre was being damaged and said four contracts may have already been lost because of the industrial strife, though it offered no details. Ironically the dispute comes at a time when the region's shipyards are enjoying a boom in orders. Private yards such as Barreras, Vulcano and MetalShips have specialised in smaller, high-tech vessels such as fast ferries. chemical tankers and offshore support ships and have collectively secured an orderbook worth more than \$1.35bn.

Seattle, May 4 — Pier 86 has first vessel on berth, following repairs to loading equipment. Four Panamax size vessels have been delayed. — Lloyd's Agents.

MARINA, LASALLE, BURLINGTON, CANADA

London, May 9 — A press report, dated today, states: Five luxury sailboats were badly damaged after the blaze began at around 0530, today, at LaSalle Marina, Burlington, sending thick black smoke toward homes on Northshore Boulevard. The Burlington fire department's Rotsma says it's too early to speculate on the cause. The Fire Marshall has been called in to investigate.

London, May 9 - A press report, dated today, states: At least five sailboats were destroyed and several others were damaged this morning in a raging fire at the Burlington Sailing & Boating Club. Two boats sank completely, and at least one leaked fuel into the water at Burlington Bay. Halton Police are treating the site as a crime scene and say several boats appeared to have been vandalised prior to the fire. About 30 boats were moored to floating docks at the marina, which is located south of LaSalle Park overlooking Burlington Bay, when fire crews responded to a 911 call just after 0500. By the time they arrived, at least three boats were fully engulfed in flames and the fire was spreading to others. Thick, black smoke drifted east toward nearby homes, and fire officials warned residents to keep their windows closed until the smoke had cleared. Officials with the Ministry of the Environment have been called in to help with the clean-up, which is expected to take several days. Fire officials estimate the damage at \$750,000, but say the figure could go much higher. Halton Police spokesperson Peter Payne said investigators don't know whether more than one person was involved, but added that a criminal investigation is now underway into what "appears to be vandalism and arson." There were no injures reported. The Fire Marshal's Office is investigating.

London, May 10 - A press report, dated May 9, states: Vandals ĥave police and Burlington marine officials baffled by somehow sneaking into a secure facility in a pre-dawn raid today and ransacking at least 36 boats before setting fire to five others, causing a fireball that sent three boats to the bottom of Burlington Bay. Two other boats at the LaSalle Park Marina, located adjacent to the Burlington Sailing & Boating Club, sustained burn damage and a 60-foot section of dock was also damaged. Early estimates pegged the damage at \$750,000 but it eventually could surpass \$1 million, according to authorities. Two boats were worth \$200,000 each and the other, a sailboat, was worth about \$40,000. All five boats could be written off. It appears the vandals used rescue flares from some of the boats to set the fires. Marina officials say the marina is gated and there was no sign of forced entry. The boats were recently put into the water and were full of fuel. Authorities estimate that 1,000 litres of fuel and oil have leaked into the water. An environmental response team arrived to deal with the cleanup, which could take days. Salvage crews will attempt to raise the boats. The boats that sank included a 27-foot sailboat, a 34-foot cruiser and a 32-foot cruiser. Two of the destroyed power boats were docked across from each other on the dock while the sailboat was several hundred feet away. They sank in about 10 feet of water. The Fire Marshal's Office is investigating.

MARINA, LINDENHURST, UNITED STATES

London, May 10 — A press report, dated May 9, states: A 50-foot boat was destroyed and two others were damaged by a fire yesterday at a Lindenhurst marina, fire officials said. No one was injured in the fire at the Surfside 3 Marina, Lindenhurst Fire Chief Bill Kienle said. About 75 firefighters responded to the alarm about 1830 hrs and brought the fire under control within about 10 minutes, he said. The cause of the fire is under investigation by the Suffolk County police arson squad but it does not appear the be suspicious, Kienle said.

REFINERY, UTAH, UNITED STATES

London, May 8 — A press report, dated yesterday, states: A fire at a Woods Cross oil refinery last night has environmentalists concerned about another facility's plans to expand

nearby. No one was hurt in last night's blaze, but firefighters said it was a spectacular fire that produced huge black clouds and leaping flames. Firefighters said it started when a diesel line erupted inside one of the furnaces. Dispatchers received several calls around 2000, last night, with callers saying they heard an explosion. Crews had the fire out within 15 minutes, but it was closer to an hour before the furnace was cool enough for firefighters to close off the valve feeding the fuel. No homes had to be evacuated and no one, including refinery employees, was hurt.

VANCOUVER PORT, CANADA

London, May 5 — A press report, dated May 3, states: A mechanical failure likely sparked a fire yesterday that caused more than \$1 million damage at the Port of Vancouver, according to investigators. The twoalarm fire broke out around 1445 Wednesday in a building owned by Nustar Cargo Co. The building housed calcium nitrate granules that are used as fertiliser. Officials said 9,800 metric tons of the chemical were stored inside. The Vancouver Fire Department says the blaze caused significant damage to the roof. About 15% of the fertiliser was also damaged.



ACCIDENT AT KARACHI INTERNATIONAL AIRPORT, PAKISTAN

Karachi, May 4 — Pakistan International Airlines (PIA) has grounded ATR 42-500, AP-BHN, after it was struck by a vehicle at Karachi International Airport at around 0300 yesterday. The aircraft was being towed from a washing bay to a parking bay to make its scheduled flight, PK-582, for Lahore via Rahim Yar Khan. The towing vehicle broke down and struck the aircraft. As a result of mishap, the aircraft's tail and side gear was damaged. A spokesman for PIA advised that the aircraft was being repaired and would take a few days to be ready for operation. An inquiry is being ordered. — Correspondent.

ACCIDENT, GOVERNORS HARBOUR AIRPORT, BAHAMAS

London, May 10 — The results of the investigation into the crash landing of a Bahamasair Dash 8 aircraft at the Governor's Harbour Airport in Eleuthera nearly three weeks ago are not expected to be completed anytime soon, according to Bahamasair's Managing Director Henry Woods. Mr. Woods said the Flight Standard Inspectorate and the Canada based Bombardier Corporation which manufactured the aircraft are conducting an intensive structural analysis of the damaged areas. "The investigation is still going on and will

be for quite some time," Mr. Woods said. "This could take another few weeks or another few months - it will be a while before a conclusion can be reached." The probe will determine if the aircraft can be repaired or replaced. According to Mr. Woods, Dash-8 aircraft cost between \$2.8 million and \$3.2 million. He also confirmed that the aircraft is still on the tarmac at Governor's Harbour Airport.

CRASH, AVERYS CREEK, NORTH CAROLINA, UNITED STATES

London, May 4 — Three people are dead after the crash of a Cessna 182 in the Averys Creek community. The Cessna 182 disappeared from radar around 1100 today. Federal Aviation Administration spokeswoman Kathleen Bergen said air traffic control lost contact with the aircraft about a mile and a half north-west of Asheville Regional Airport. The wreckage is in a densely wooded area.

London, May 5 - A press report, dated May 4, states: A small aircraft crashed today in rural western North Carolina, killing the three men on board, officials said. The single-engine Cessna 182 was on its way from Dublin, Ga., to Asheville Regional Airport when it disappeared from radar around 1100 hrs. Air traffic control lost contact with the aircraft about one mile from the airport, said Kathleen Bergen. spokeswoman for the Federal Aviation Administration. Killed were James V. Hilburn, Jefferson I. Davis III and James Rodney Connell, according to a statement from W.H. Bud Barron Airport in Dublin. The aircraft, built in 1977, was registered to Hilburn and two other men not on the aircraft, according to the FAA and the airport. The men were on their way to pick up a car that Hilburn, a Dublin attorney, was buying The National Transportation Safety Board was investigating.

London, May 8 — Cessna 182Q (Skylane) N735DP crashed near Asheville, North Carolina, at 1500, May 4, while on a flight from Dublin, Georgia, to Asheville. The aircraft was destroyed. The three persons on board were killed.

CRASH, DILLON AIRPORT AREA, MONTANA, UNITED STATES

London, May 4 - A press report, dated today, states: A Cessna Citation II from Illinois crashed near Dillon Airport yesterday while trying to land in rough weather, killing both men on board, Beaverhead County officials said. The pilot filed a flight plan that said the aircraft was headed to Montana from Rockford, IL, Sheriff Jay Hansen said in a statement. The sheriff's department received a report of an explosion near the airport at 1040 hrs, Hansen said. Dillon police, fire and emergency medical personnel arrived at the scene to find that an aircraft had crashed about $300\ \mathrm{yards}$ east of the airport in an adjacent field. Investigators with the Federal Aviation Administration arrived on the scene yesterday afternoon

investigators from the National Transportation Safety Board were scheduled to arrive yesterday evening.

London, May 5 — Cessna Citation II N22HP, operated by Hamilton Ranches, which departed Greater Rockford Airport at 0843, CDT, May 3, on a flight to Dillon, Montana, crashed while on approach to Dillon at 1040, May 3. The two persons on board were killed and the aircraft was written off.

CRASH, DOUALA AREA, CAMEROON

London, May 5 - A press report, dated today, states: A Kenya Airways Boeing 737-800 with 114 people on board has reportedly crashed in southern Cameroon. The flight, which originated in Ivory Coast, was reported missing today after it failed to arrive in Nairobi. Cameroon state radio said the aircraft came down south of Douala, although Kenya Airways has only confirmed so far that it is missing. People of at least 23 different nationalities were on board, including five Britons, the airline said. The Boeing 737-800 involved in the incident was reportedly just six months old and was part of a new fleet bought by the airline. Flight KQ 507 originated in Abidjan in Ivory Coast and left Douala in Cameroon at 0005, local time today. It was due to arrive in Nairobi at 0615, local time. Kenya Airways said the last communication with the missing aircraft was received by the control tower in Douala, shortly after take-off. Cameroon radio initially said the aircraft came down near Niete, south along the coast from Douala, although later reports suggested the crash had happened further inland. "The search location has now been centred around 100 km south-west of Yaounde,' Kenyan Airways chief executive Titus Naikuni told a news conference. He said an extensive search of the area by low-flying aircraft had found nothing, and a second search team was on its way to the site. Poor weather is reported to have hampered the rescue effort.

London, May 6 - A press report, dated today, states: Authorities in Cameroon have suspended their search until daybreak for a missing Kenya Airways passenger aircraft with 114 people on board, which is feared to have crashed in dense forest. Throughout the day helicopters and aircraft from the military have searched a vast area of forest in southern Cameroon where it is feared the six-month-old Boeing 737 crashed in the early hours of yesterday in treacherous weather conditions. From midday onwards the search focused on a region around the town of Lolodorf, 100 km south-west of Yaounde, where witnesses said they heard a loud explosion overnight, Cameroon state radio and TV said. Officials from Kenya Airways have not yet confirmed that its aircraft has crashed. However, an official with the Kenyan Civil Aviation Authority, who asked not to be named, said "the plane has crashed". Kenya Airways chief executive Titus Naikuni said the aircraft had been delayed from taking off by one hour due to heavy rain and that poor weather was hampering the search. A satellite picked up a distress signal from the aircraft at 0200, local time, nearly two hours after it had taken off.

London, May 6 — A press report, dated today, states: Searchers in southern Cameroon have found the wreckage of a Kenya Airways Boeing 737-800 that went missing yesterday, officials have confirmed. The aircraft, which originated in Ivory Coast, came down after taking off in heavy rain from Douala en route to the Kenyan capital, Nairobi. The aircraft was carrying 114 people. It was found in mangroves close to the airport in Douala, officials said. "Kenya Airways regrets to confirm that its flight KQ 507 has been located on a mangrove swamp 20 km south of Douala," CEO Titus Naikuni told a news conference in Nairobi. He said the reason the aircraft was not found earlier was because it was covered with trees. Rescue workers were at the site, he said, but there was "no confirmed information about survivors or any possible casualties".

London, May 7 — A press report, dated today, states: None of the 114 people on board a Kenya Airways Boeing 737-800 flight survived its crash into a thick mangrove swamp over the weekend (May 5-6), an official said today after returning from the water-filled crater he said the aircraft left. Asked whether anyone survived, Luc Ndjodo, a local government official in charge of the recovery effort, said: "No. I was there. I saw none." A US Embassy official who saw the crash site from an aircraft today said it would have been impossible to have found it from the air without co-ordinates provided by searchers on the ground. Flight 507 had departed from Douala airport early Saturday, an hour late because of rain. The aircraft issued a distress call, but then lost contact with the radio tower between 11 and 13 minutes after takeoff, officials said. One of the many unanswered questions is why the aircraft stopped emitting signals after an initial distress call. The aircraft is equipped with an automatic device that should have kept up emissions for another two days. The aircraft was only six months old.

London, May 8 - A press report, dated today, states: Crash investigators in Cameroon have found one of the black box data recorders from the Kenya Airways Boeing 737-800 which crashed on Saturday (May 5). It is thought the recorder may help determine the cause of the crash which is believed to have killed all 114 people on board. Speaking today at a news conference in Nairobi, Titus Naikuni, the chief executive officer of Kenya Airways, said there was no confirmed information regarding casualties or survivors, but added: "We will continue to provide confirmed information as we receive it.'

London, May 9 — A press report, dated today, states: U.S. aviation experts conferred with their Kenyan and Cameroonian counterparts today in an international effort to determine

what caused a Kenya Airways Boeing 737-800 to crash into a central African swamp and kill all 114 on board. The Americans, from the National Transportation Safety Board, were meeting with the African experts in preparation for their contribution to the investigation, said Lonnie Kelley, the U.S. Embassy spokesman in Cameroon. Experts from Boeing, which made the aircraft were also expected. Evanson Mwaniki, Kenya Airways chairman, said the company was also bringing in British forensic and DNA specialists and equipment to help identify bodies. Bodies were being found in pieces and badly decomposed after more than 40 hours in the water. making the "identification process more complicated and time consuming, Mwaniki said. Kenya Airways officials said today that the remains of 81 of those on board had been recovered so far. Kenya Airways chief Pilot James Ouma told a Nairobi news conference yesterday that the Kenyan crash investigators at the site now believe Flight 507 crashed about 30 seconds after take-off. Officials in Cameroon had said earlier that they lost contact with the aircraft 11-13 minutes into flight. The investigation has just begun, and the discrepancy could not immediately be explained. Kenyan officials also said yesterday they would like the flight data recorder, which was discovered Monday (May 7), to be examined in Canada, but acknowledged the decision would be made by Cameroon.

CRASH, EAST FARMINGDALE, LONG ISLAND, UNITED STATES

London, May 7 — A press report, dated today, states: Federal investigators said a mechanical problem probably caused a small aircraft to crash shortly after take-off on Long Island injuring the pilot and his one passenger. The accident was around 0900, Saturday (May 5), near Republic Airport in East Farmingdale. An FAA investigator said the pilot was an experienced pilot and the crash appeared to have been caused by a mechanical problem right after take-off.

London, May 8 — Aviat A-1A (Husky) N16HY flipped over on take-off from Farmingdale, New York, at 1240, May 5. The aircraft was destroyed. The two persons on board suffered minor injuries.

CRASH, MARSTON MILLS, MASSACHUSETTS, UNITED STATES

London, May 6 — A press report, dated May 5, states: A small aircraft crashed into a house in Marstons Mills, MA, this morning. Marstons Mills' fire chief John Farrington said an off-duty fireman saw the Cessna 152 drop below the tree line and heard it crash into the roof of 356 Race Lane shortly after 1100. The home's residents were outside in the back yard at the time of the accident. The pilot, Alessandro Mendonca, was the only person in the four-seat aircraft and was speaking when firefighters took him out of the

wreckage. The aircraft was owned by Sky Dive Cape Cod. The pilot had dropped three parachutists, but the aircraft developed engine trouble on the way back to Cape Cod Airport, about a mile away from the house. Witnesses said crews had to cut the aircraft's door off to rescue Mendonca. He was rushed to Cape Cod hospital. No one on the ground was injured.

London, May 8 — Cessna 182A N403RA crashed near Marstons Mills, Massachusetts, at 1505, May 5, while on a local flight from Marstons Mills. The aircraft was destroyed. The one person on board suffered minor inturies.

CRASH, OXFORD COUNTY REGIONAL AIRPORT, MAINE, UNITED STATES

London, May 9 - A press report, dated today, states: A student pilot from Waterville escaped serious injury last night when his Cessna 172 overshot the runway at Oxford County Regional Airport and flipped over in a swampy ditch about 100 feet from dozens of unoccupied manufactured homes. Jaroslav Suchanek, who was flying solo, was taken to Central Maine Medical Centre in Lewiston with head injuries and admitted overnight for observation, Maine State Police Trooper Dan Hanson said. Suchanek was out of the aircraft, bloodied, but walking when rescuers arrived moments after the 1700 hrs accident, Oxford police Chief Jonathan Tibbetts and other witnesses said at the scene. The airport will remain closed until the FAA is finished. Suchanek took off from Central Maine Regional Airport in Norridgewock in a 1975 single-engine Cessna 172 owned by and registered to Kenneth Morgan of Norridgewock. Hanson said. Suchanek was on a training flight from Norridgewock to Oxford, and planned to then go to Augusta before returning Norridgewock that night. His plane is insured and he would check the damage this morning. Firefighters from Oxford rushed to the scene and doused the aircraft with foam in an attempt to keep the leaking fuel from exploding. Maine State Police immediately cordoned off the airport, preventing anyone but rescue personnel and firefighters from approaching. Hanson said there was heavy front-end damage to the fixed-wing aircraft.

CRASH, PALMER AREA, ALASKA, UNITED STATES

London, May 8 — Cessna 170 N4217V crashed near Palmer, Alaska, at 0001, May 5, while on a local flight from Palmer. The aircraft was destroyed. The one person on board was killed.

London, May 9 — A press report, dated May 8, states: Alaska State Troopers report that a pilot died Friday (May 4) when his small plane crashed in a neighbourhood north of Wasilla. Authorities say 49-year-old Robert Sellers of Wasilla died when his Cessna 170 crashed just after take-off. They say the plane came down in a wooded lot between two homes in Hart Lake Estates, west of Wolf Lake.

CRASH, SOUTH MCALLEN, UNITED STATES

London, May 4 — Lancair IV-P N119TC crashed near McAllen, Texas, at 2358, May 2, while on a local flight from McAllen. The aircraft was destroyed. One of the two persons on board was killed and the other was seriously injured.

CRASH, SPANISH FORK CANYON, UTAH, UNITED STATES

London, May 8 - A press report, dated May 7, states: A Seattle man was killed today in a small aircraft crash in northern Ŭtah. Utah County sheriff's Sergeant Spencer Cannon said Craig Webster died in the crash in Spanish Fork Canyon, south of Salt Lake City. Cannon said Webster was on his way home to Seattle after leaving San Antonio, Texas, yesterday. Webster was flying a Cessna 210 to Twin Falls, Idaho, after leaving an airport in Price, Utah, about 120 miles south-east of Salt Lake City. Officials saidhe sent out a distress call, saying the cabin was filling with smoke. Investigators believe Webster was the only person on board.

CRASH, VIENNA, YOUNGSTOWN AREA, OHIO, UNITED STATES

London, May 4 - A press report, dated today, states: The Ohio State Highway Patrol is trying to determine what brought down a Cessna 210 aircraft in Ridge Road in Vienna shortly before 1500 yesterday. The aircraft was flying eastbound over Ridge Road. The aircraft's pilot, experienced engine complications while approaching Youngstown Airport. The aircraft crashed onto Ridge Road striking a utility pole, tree and then fence. The pilot was the only person on the aircraft. The FAA responded to the scene and is currently investigating what may have caused the crash.

CRASH, WEST MICHIGAN, UNITED STATES

London, May 3 — A press report, dated today, states: Two men are recovering after a small aircraft crash in west Michigan. It happened Tuesday (May 1) in Ottawa County's Crockery Township. Investigators say the aircraft had engine failure shortly after take-off, clipped some power lines and went down near a blueberry field. Neighbours in the area say they rushed to help get the pilot and the passenger out of the wreckage.

London, May 3 — Luscombe 8A (Silvaire), N1120B, operated by Daniel E.Sherburn, with two persons on board, forced-landed in a field at Nunica, Michigan, at 2125, UTC, May 1. Both persons on board were seriously injured.

EMERGENCY LANDING, BOSTON, MASSACHUSETTS, UNITED STATES

London, May 10 — A press report, dated May 8, states: A JetBlue aircraft had to return to Logan International Airport, Boston, MA, today after an engine stalled just after take-off. The aircraft, which was headed to JFK

airport in New York, quickly turned around and landed a short time later. No injuries were reported and the aircraft was towed from the runway.

EMERGENCY LANDING, BUSH INTERNATIONAL AIRPORT, HOUSTON, UNITED STATES

London, May 10 — A press report, dated yesterday, states: Continental Airlines aircraft landed safely at Houston's Bush Intercontinental Airport after reporting engine problems tonight. The crew of the Boeing 757 reported trouble shortly after 2030 hrs, but landed without incident at 2051 hrs, said Marlene McClinton, spokeswoman for the Houston Airport System. The airliner had 98 people on board, she said.

EMERGENCY LANDING, KANSAS CITY, KANSAS, UNITED STATES

London, May 9 — A press report, dated May 8, states: A United Airlines flight carrying 143 people made a safe emergency landing at Kansas City International Airport about 1130 today. No one was injured. Flight 267 was en route to Denver from Philadelphia, said KCI spokesman Joe McBride. The pilot reported that an engine was out, he said.

EMERGENCY LANDING, OHAKEA AIRBASE, NEW ZEALAND

London, May 3 - A press report, dated today, states: An Air New Zealand Boeing 737 with 122 people on board has made an emergency landing at Ohakea Airbase after a report of smoke in the cockpit. The Boeing 737 was flying from Wellington to Auckland when it experienced an electrical fault. Air New Zealand says the pilot diverted to Ohakea after smelling smoke and landed safely. At least 10 MPs were on board the flight including the cabinet minister David Cunliffe, who says smoke was visible at the front of the passenger cabin. He says everyone remained calm and the cabin crew and pilot did an excellent job. My Cunliffe passengers missed says some international flights out of Auckland. Those who were on board the flight waited in the gymnasium at Ohakea Airbase for another aircraft to arrive.

London, May 4 - A press report, dated today, states. An Air New Zealand Boeing 737 carrying several MPs made an "emergency landing" at the Ohakea military airbase in the central North Island last night. The pilots reported smoke in the cockpit of the aircraft and a full emergency was called. The aircraft, bound for Auckland from the capital, had 122 passengers and crew on-board. After landing passengers were forced to wait for another aircraft to get clearance to land at Ohakea to take them on to Auckland. It took a call from MP Chris Carter to transport Minister Harry Duynhoven for the situation to be resolved and passengers finally arrived in Auckland after 0300 today. The aircraft is still at Ohakea where investigators are trying to find the fault but it is thought at this stage to be confined to just the one aircraft.

London, May 5 - A press report, dated today, states: An electrical fault and reports of smoke in the cockpit forced a Boeing 737, flying from Wellington to Auckland, to land at the Ohakea air base, just before 2200 Thursday (May 3.). There were more than 120 people on board. The electrical fault was discovered to be in a pilot's headset panel. Transport safety authorities handed the aircraft back to Air New Zealand yesterday afternoon, but it stayed at Ohakea overnight as engineers from the airline continued to make further checks. The aircraft was taken on a test flight early today and arrived in Auckland just before 0800

EMERGENCY LANDING, ST. PETERSBURG, RUSSIA

London, May 7 — A press report, dated May 6, states: A Boeing 737, Flight 2771 from St.Petersburg to Amsterdam, made an emergency landing at St. Petersburg's Pulkovo airport, the city's emergency situations department said. "The crew made the decision to turn back to the airport after the inertial system broke down 14 minutes into the flight. There were 113 passengers and seven crew on board the aircraft. No-one was hurt," a department spokesman said.

EMERGENCY LANDING, TEHRAN, IRAN

London, May 5 — A press report, dated today, states: A Mumbai-bound Turkish Airlines flight from Istanbul made an emergency landing at Tehran yesterday following a technical fault. The aircraft, which took off at 1900, Istanbul time, made the unscheduled halt after two-and-a-half hours of flight. The aircraft had about 127 passengers on board, most of them Indians. A passenger on board said that the aircraft was forced to land at Tehran and the cabin crew informed the passengers that it was due to a technical fault.

INCIDENT AT INDORE AIRPORT, INDIA

London, May 8 - A press report, dated today, states: A private aircraft with at least 10 people on board skidded off the runway at Indore Airport and slammed into a boundary wall, an airport official said today. The aircraft belonging to Mumbai-based Essar Aviation Company veered off the runway yesterday, airport Director R K Singh said. All those on board were safe and a three-member team from the Directorate General of Civil Aviation (DGCA) has begun a probe into the mishap. The aircraft, coming from Mumbai, landed safely and was heading towards a parking bay when it skidded off the runway, he said. "The probe will reveal whether the accident was caused by pilot error, equipment failure or bad weather," he said. The aircraft is still stuck at the site and the company is making arrangements to pull it back on to the runway, he said.

INCIDENT AT MUMBAI AIRPORT, INDIA

London, May 4 — A press report, dated today, states: Passengers of Qatar Airways were delayed at Mumbai Airport for 15 hours after their aircraft developed a technical fault. The flight finally left at 2100 yesterday. The flight, which was due to leave for Doha at 0555 yesterday, had 256 passengers on board. One group of 74 tourists was booked with Cox & Kings, and another group of 67 was booked with SOTC. While the airline arranged for the SOTC passengers to board a Jet Airways flight to London, it failed to send the group of 74 or any of the remaining passengers on the next British Airways flight, saying that seats were limited. Initially, take-off was delayed for two hours, but in the evening passengers were told that they would be able to board at 2100 yesterday, after a delay of 15 hours. Several passengers said Cox & Kings had made bulk bookings on Qatar Airways at heavy discounts, one reason why they were unable to accommodate passengers on other flights. A Qatar Airways spokesman said passengers were offered a place to stay, though the offer was made late in the evening.

INCIDENT AT O'HARE INTERNATIONAL AIRPORT, UNITED STATES

London, May 3 - A press report, dated today, states: A baggage cart tug struck a United Airlines jetliner at O'Hare International Airport this morning, prompting an emergency response from firefighters. But there were no injuries, authorities said. Crews were called about 0700 hrs to a gate area of the airport after the tug "clipped the fuselage" of an aircraft, Chicago Fire Department spokesman Richard Rosado said. The incident involved a United Airlines jet, Chicago Aviation Department spokeswoman Wendy Abrams said. Rosado said there was no fuel spill and the scene was secured within 10 minutes. No one was injured, he said.



AUSTRALIA

London, May 4 — A press report, dated today, states: The Federal Government would not accept blame for Hunter coal bottlenecks, but would be prepared to work with the New South Wales Government to find a way to ease congestion, prime minister John Howard said yesterday. Eight months spent battling an inflated vessel queue has fostered frustration among capacity providers and coal companies, and each side attributes blame for the congestion to each other. Mr Howard said on Sydney radio that while Australia's coal terminals were out of the Federal Government's control, he still planned to call NSW premier Morris Iemma to

discuss what both governments could do to ease the bottlenecks. "Some part of the problem may not be capable of being fixed immediately because there are private interests involved and sometimes when private interests conflict, the public interest is not always well served," Mr Howard said. The operator of both coal terminals at the port of Newcastle, Port Waratah Coal Services (PWCS), has made it clear that it wants to slash the present queue of about 70 vessels to a work queue of under 30. Xstrata and Coal & Allied this week blamed the Australian Rail Track Corporation (ARTC) for not providing enough capacity but ARTC chief David Marchant said it had delivered more capacity than the port could handle. The ARTC said it had 120mtpa of capacity along the 68-km arterial line from Whittingham to the port, while PWCS was providing 102mtpa. PWCS told coal companies that they would not be allocated as much capacity as they had asked for. "PWCS confirms that with the reintroduction of the CBS in March 2007, all producers received a reduced allocation for 2007 compared to what they originally requested," PWCS said in a statement on Wednesday (May 2). The original demands for capacity made by coal producers "substantially exceeded planned coal chain capacity", PWCS said. The coal chain providers plan to provide 90m tonnes of capacity in 2007 but the capacity balancing system has since been re-introduced. Coal vessels are waiting 27 days on average to load coal from Newcastle.

London, May 8 - A press report, dated May 6, states: Coal miners in the Boggabri and Gunnedah basins, in New South Wales' north, say they have cut back production because of congestion at the port of Newcastle. Quota allocations at the port, which are designed to ease the backlog, have meant the region's mines have had to reduce production by cutting shift times and making workers enforced leave. The bottleneck is due to delays in upgrading facilities at the port and the slow rail delivery of coal to the port itself. The general manager at Boggabri Mine, Thor Berding, says if the delays continue, some workers could lose their jobs. "We've been able to reduce production by allocating less work time per shift and by taking public holidays and scheduling Christmas break shutdowns and things like that," he said. "Just reduce working times and no people have been laid off at this stage."

London, May 9 — A press report, dated today, states: The queue of vessels waiting to load coal at Newcastle, New South Wales, the world's largest coal-export harbour, may shorten by about half by June, according to an industry group. The number of vessels may drop to 54 by the end of May and 39 by the end of June based on forecast arrivals, the Hunter Valley Coal Chain Logistics Team, which is responsible for planning all coal exports from the region, said on its Web site. It also said Newcastle's export capacity increased to 7.8 million

tons of coal a month in April from 6.6 million in February. "Coal availability remains very good," Hunter Valley Coal Chain said. The expected drop in the ship queue is "subject to the coal chain delivering its declared capacity and arrivals matching forecast. Bottlenecks at the port and on the rail system in New South Wales state are preventing miners from fulfilling orders, raising their costs. Port Waratah Coal Services Ltd., operator of the coal terminals at Newcastle, said all coal shippers using the port will have their capacity allocations cut this year due to high demand. Hunter Valley Coal Chain's indicative demurrage rate is A\$6.04 (\$5) per ton, it said. Demurrage is the cost paid to a ship owner when a vessel is kept waiting to load its cargo beyond a scheduled time. The queue of vessels waiting to load rose by three to 70 for the week ended May 7, the Newcastle Port Corp. said on its Website. The length of vessels rose to record of 74 in the week ended Apr 23, up from a low of five in December 2005. The Baltic Panamax Index rose 1.5% yesterday to 6.028, the highest Dec 6, 2004. The index measures the cost of hiring Panamax dry-bulk carriers, the class of vessel that carries most of Newcastle's coal exports. The average daily rate to hire a Panamax vessel rose 1.4% to \$48,672 yesterday, the fifth day it advanced, according to the Londonbased Baltic Exchange. It has surged 40% this year. In a bid to reduce shipping delays, Hunter Valley mining companies voted to re-introduce an export quota system at Newcastle in February. Almost 90% of coal shipped through Newcastle last year was thermal coal produced in the Hunter Valley. The port accounts for about a third of Australia's coal- export capacity. Port Waratah Coal Services has spent A\$170 million (\$141 million) on infrastructure upgrades in the past 12 months, "but significant capacity increases arising from major infrastructure investment takes year to complete," it said in a statement May 2. Its terminal has a capacity of 102

million tonnes and in the first quarter it had a throughput of 84.5 million tonnes.

ISRAEL

London, May 8 - Israeli shippers are threatening legal action against the country's ports, which they argue have descended into "anarchy". The development comes after the Manufacturers' Association and the national Shippers' Council and the Chamber of Shipping held an emergency conference in Tel-Aviv last week. According to leading Israeli newspaper the Jerusalem Post, around 100 people took part in the conference, organised under the slogan "Blockade on the ports — an outrage." Speakers reportedly complained of delays of up to 20 days, mostly because of a lack of port personnel and equipment. Delays are said to be costing companies millions of shekels in storage fees, late fines and cancelled orders. The conference also decided to sue the ports over what is said were unjustified storage and congestion fees. Chamber of Shipping president Reuven Zuck said some 20 container ships were currently waiting to enter the port of Haifa, with a further 11 waiting to dock in Ashdod. The conference was held two days after the release of the Tonic Report, commissioned by the Transportation Ministry to investigate operations in Israel's transportation and ports during the war with Lebanon last year. The report was critical of port management, especially Ashdod, which received most traffic prevented from using Haifa because of security concerns. Shraga Brosh, president of the Manufacturers' Association, said the main problem was lack of staff. He blamed bureaucracy for preventing Ashdod from hiring an authorised 100 extra workers there. Haifa and Ashdod port managers Amos Chozni and Shuki Sagis complained about long-standing problems in infrastructure, labour agreements and management procedures. But Ashdod's management issued a statement insisting up to 100 new port employees would be hired within two months.

ITALY

Genoa, May 7 — Current berthing delays: Genoa: One container carrier waiting to berth. Average delay in berthing 12 - 24 hrs. La Spezia: No vessels waiting to berth. Savona: No vessels waiting for normal berth. Two vessels waiting for special berth. — Lloyd's Agents.

NIGERIA

London, May 7 - A press report, dated today, states: A large number of vessels, reported to be as many as 60, are waiting outside Nigeria's port of Lagos because pilot boats are not available to deliver marine pilots to take the ships to available berths. The Lagos newspaper Vanguard reported on Friday (May 4) that Nigeria's National Ports Authority (NPA) has been unable to provide the pilot boats necessary for the transfer of marine pilots to the waiting ships. It said all four pilot cutters had broken down or were unserviceable. As a result vessels waiting to go to berth at Tin Can Island or Apapa have been unable to move from where they are at anchor outside. All that is known is that the NPA, which holds the responsibility for marine activity at the two ports, including the provision of pilotage, is experiencing "problems" with the pilot boats and the exact nature has not been disclosed.

PANAMA CANAL

Balboa, May 9 — Delays for nonbooked vessels stand at about two to three days with decreasing tendency. The present backlog is a direct consequence of the recent lane outage at Gatun which coincided with heavy arrivals. The booking system remains at full level of utilisation and the slot offered through Auction continues to attract Customers willing to pay large premiums looking to avoid delay. During periods of maintenance, Canal Capacity is significantly reduced, and vessels with no booking can be exposed to major delays. This is particularly noticeable during long outages. -Lloyd's Agents.
